Domestic sales of refined petroleum products

October 1999 (preliminary)

Sales of refined petroleum products totalled 8 084 800 cubic metres in October, down 0.7% from the same month in 1998. Sales increased for five of the seven major product groups compared with the same period in 1998, with the largest gains for diesel fuel oil (+107 200 cubic metres or +5.6%) and light fuel oil (+60 500 cubic metres or +18.4%). Sales of heavy fuel oil dropped drastically (-275 300 cubic metres or -31.6%) from October 1998.

Year-to-date sales of refined petroleum products were up 806 100 cubic metres (+1.0%) over the same period in 1998. Sales increased for five of the seven major product groups, with the largest advances for motor gasoline (+812 700 cubic metres or +2.6%) and diesel (+404 600 cubic metres or +2.3%). These two products accounted for almost 65.0% of the total sales of refined petroleum products.

The gain for light fuel oil (+232 900 cubic metres or +6.5%) was mostly due to greater use of the product

for heating in the first half of the year. The decline for heavy fuel oil (-573 000 cubic metres or -8.4%) was due to greater use of natural gas in place of heavy fuel oil by the industrial sector.

Pipeline transportation of crude oil and refined petroleum products

September 1999

Net receipts of crude oil and equivalent hydrocarbons totalled 12 377 965 cubic metres in September, down 3.2% from September 1998. Year-to-date receipts to the end of September were 110 431 623 cubic metres, down 4.9% from the same period in 1998. Net receipts of liquefied petroleum gases and refined petroleum products in September (6 493 152 cubic metres) increased 0.2% from September 1998. Year-to-date receipts increased 0.6% to 58 277 072 cubic metres.

Pipeline exports of crude oil (5 287 522 cubic metres) decreased 6.8% from September 1998, and pipeline imports (1 557 694 cubic metres) decreased 9.0%. Year-to-date exports (49 088 166 cubic metres) were down 10.1% from 1998. Year-to-date imports (14 967 002 cubic metres) increased 7.1 %.

September deliveries of crude oil by pipeline to Canadian refineries totalled 5 542 870 cubic metres, an 8.1% decrease from 1998. September deliveries of liquefied petroleum gases and refined petroleum products decreased 6.3% to 590 685 cubic metres. Year-to-date deliveries of crude oil to refineries at the end of September totalled 50 806 805 cubic metres, down 0.3% from the same period in 1998.

Oils and fats

October 1999

Production of all types of deodorized oils in October totalled 106 873 tonnes, a 3.3% decrease from 110 511 tonnes in September. Year-to-date production for October was 927 767 tonnes,

down 10.1% compared with 1 031 428 tonnes for the same period in 1998.

Domestic sales of deodorized margarine oil totalled 12 189 tonnes. Sales for deodorized shortening oil were 28 391 tonnes and sales for deodorized salad oil amounted to 30 036 tonnes in October.


