

# New release date for quarterly financial statistics for enterprises

First quarter 1999

Over the last year, the process of producing the quarterly financial statistics for enterprises has been undergoing a major redesign. Major factors in the redesign have included: implementation of the new North American Industrial Classification System (NAICS), new questionnaires, a new sample along with related methodological changes, and new computer systems designed to ensure Y2K compliance. As announced last week, due to these substantial changes the data will not be released today. Instead, a brief summary of data will be published June 9 followed by more complete data later in June.

## **Employment Insurance**

March 1999 (preliminary)

An estimated 524,820 Canadians received regular Employment Insurance (EI) benefits in March, down 0.7% from February.

The decrease in Ontario (-4.5%) was in line with other economic indicators as reported by the Labour Force Survey and the Survey of Employment, Payrolls and Hours. Increases were observed in New Brunswick (+3.9%), Newfoundland (+3.6%), Alberta (+2.6%) and British Columbia (+1.2%) while numbers in other provinces remained relatively unchanged. Regular benefit payments decreased 2.1% in March to \$666.2 million and claims received decreased 2.0% to 227,400.

ote: All beneficiaries includes all claimants paid regular benefits (e.g., due to layoff) or special benefits (e.g., due to illness).

**Note:** The number of beneficiaries is a measure of all persons who received EI benefits for the week containing the 15th of the month. The regular benefit payments series measures the total of all monies received by individuals for the entire month. These different reference periods must be considered when comparisons are done between the series. The Employment Insurance Act allows each province or administrative region of Human Resource Development Canada to have certain autonomy in the application administrative procedures regarding renewal claims. Data users must take into consideration that movements in levels from month to month may be affected by different administrative procedures regarding renewal claims from one province or region to another. The seasonally adjusted regular beneficiaries data series (1975-1998) has been revised to reflect the final 1998 data.

### Railway carloadings

Seven-day period ending May 7, 1999

Non-intermodal traffic loaded during the seven-day period ending May 7, 1999, decreased 2.0% to 4.8 million tonnes compared with the same period of last year. The number of cars loaded increased 0.6%.

Intermodal traffic tonnage totalled 377 000 tonnes, a 5.6% increase from the same period of 1998. The year-to-date figures increased 12.5%.

Total traffic decreased 1.4% during the period. This brought the year-to-date total to 88.3 million tonnes, a decrease of 3.7% from the previous year.

All year-to-date figures have been revised.


