### Crushing statistics

June 1999

Canadian oilseed processors crushed 193 204 metric tonnes of canola in June, according to the monthly survey of crushing plants. Oil production totalled 81 709 tonnes while meal production amounted to 122 703 tonnes.

In the first 11 months of the 1998-99 crop year, the canola crush volume was 2 878 849 tonnes, a 3.7% decline from the August 1997 to June 1998 crush quantity of 2 990 113 tonnes.

### Mineral wool including fibrous glass insulation

June 1999

Manufacturers shipped 1 741 472 square metres of R12 factor (RSI 2.1) mineral wool batts in June, down 45.0% from 3 168 919 square metres a year earlier and down 41.3% from 2 968 002 square metres a month earlier.

Year-to-date shipments to the end of June totalled 15 625 478 square metres, a 1.2% decrease from the same period in 1998.

Despite the emphasis on taking urban transit, Canadians are using it less and less. In 1995, each Canadian took an average of about 65 trips on some form of urban transit, the lowest level in the past 25 years.

Growth in productivity among Canadian businesses was notably weak again in 1996 accompanied by sluggish gains in employment and slow nominal growth during the year.
