Employment, earnings and hours

November 1999 (preliminary)

In November, average earnings for all employees increased slightly to \$616.04 per week, up \$2.29 from October. Over the last 12 months, average earnings have increased 1.5%.

At the industry level, average earnings gains over the preceding 12 months for most industries were moderate, ranging from 1.0% to 2.5%. Workers in logging and forestry services registered the largest annual earnings increase (+5.0%), which was due primarily to gains in hours worked by hourly paid employees.

Hourly rated employees in all industries earned an average of \$15.38 per hour in November, a 2.3% increase from November 1998. Compared with a year earlier, growth in hourly earnings has been strongest in service-producing industries.

Average weekly hours (including overtime) for hourly paid employees were up 0.2 hours in November to 31.4 hours per week, although average overtime hours remained unchanged for the same period. While average weekly hours have not changed from November 1998, total paid hours for hourly employees have increased in the last year due to increases in the number of hourly employees.

Payroll employment increased substantially in November, continuing the upward trend that began in mid-1999. Total employment increased by 56,000 in November, with strong gains in manufacturing, construction and business services. Employment levels increased in almost all provinces with the

strongest growth in Ontario, Quebec, Alberta and British Columbia.

Statistics Canada has completed the third Note: phase of its redesign in the use of administrative records for the production of employment, earnings and hours estimates. With the change in methodology, employment estimates derived from administrative records may show a different seasonal pattern than the previous data, which were derived from survey questionnaires. The impacts on seasonal patterns due to this change in methodology can only be assessed over a longer time period. Statistics Canada will continue to monitor these impacts and will help users interpret its data. To minimize impacts, data from the Survey of Employment, Payrolls and Hours, particularly employment data, should be used in the context of longer time periods for detailed industry distributions.

Coal production

1999 (preliminary)

Lower demand in export and domestic markets as well as production problems in Nova Scotia in 1999 led to a decline in coal production for the second consecutive year, according to preliminary estimates. Production is expected to fall 4.0% from 1998 levels to 72.3 million metric tonnes.

British Columbia is the only producing province expected to register an increase in coal production. The value of coal production is expected to decline 15.9% to \$1.5 billion as stiff competition in export markets is leading to steep price cuts at the expiry of export contracts. The price per ton of Canadian coal is the lowest since 1977.

Steel primary forms

Week ending January 22, 2000 (preliminary)

Steel primary forms production for the week ending January 22, 2000 totalled 309 689 tonnes, down 6.1% from the week-earlier 329 885 tonnes and up 17.1% from the year-earlier 264 500 tonnes. The cumulative total at the end of the week was 991 793 tonnes, an 18.2% increase compared with 838 936 tonnes for the same period in 1999.

In November, Canadian Airlines reported an 8% increase in their domestic operations (seasonally adjusted passenger-kilometres). This is the second consecutive monthly increase.


