Help-wanted Index

June 2000

In June, the Help-wanted Index (1996=100) remained unchanged at 169. While there was little change in most provinces, the index increased by an estimated 4.3% in Newfoundland and decreased by 1.8% in Nova Scotia and 1.4% in British Columbia.

Note: The Help-wanted Index is compiled from the number of help-wanted ads published in 22 newspapers in 20 major metropolitan areas. The index is a measure of companies' intentions to hire new workers. These indices have been seasonally adjusted and smoothed to ease month-to-month comparisons.

Pipeline transportation of crude oil and refined petroleum products

April 2000

Net receipts of crude oil and equivalent hydrocarbons totalled 12 564 137 cubic metres in April, up 4.2% from April 1999. Year-to-date receipts to the end of April were 51 424 795 cubic metres, up 7.1% over the same period in 1999. Net receipts of liquefied petroleum gases and refined petroleum products were 6 577 791 cubic metres, an increase of 3.3% from April 1999. Year-to-date receipts were 27 145 758 cubic metres, a rise of 5.0% over the same period of 1999.

Pipeline exports of crude oil were 5 870 329 cubic metres, an increase of 12.3% from April 1999, and pipeline imports totalled 1 776 362 cubic metres, a 2.6% advance. Year-to-date exports were 23 325 193 cubic metres, up 14.3% from 1999. Year-to-date imports totalled 7 975 382 cubic metres, a 26.5 % advance over the same period in 1999.

April deliveries of crude oil by pipeline to Canadian refineries totalled 5 364 358 cubic metres, an increase of 7.6% from 1999. April deliveries of liquefied petroleum gases and refined petroleum products decreased 17.2% to 608 166 cubic metres. Year-to-date deliveries of crude oil to refineries at the end of April totalled 22 855 936 cubic metres, up 2.8% from the same period in 1999.

Despite the emphasis on taking urban transit, Canadians are taking it less and less. In 1996, about 1.4 billion trips were taken on public transit, a decline from 1.5 billion trips in 1995.
