



RAILWAY FREIGHT TRAFFIC

JANUARY 1963

Presented in this report are revenue freight traffic statistics of twenty-three class 1 and 2 railways operating in Canada (the C.N.R., C.P.R. and other carriers having average gross revenues of \$500,000 or more annually) as follows:

Excluded from this report are details of class 3 and 4 roads (companies with annual revenues of less than \$500,000) whose traffic represents about one per cent of all common carrier rail movements. Freight interchanged between Canadian railways is not duplicated in these data.

During the month of January, revenue freight loaded on lines in Canada and received from United States rail connections rose 7.0 per cent to 11,638,089 tons from 10,877,529 tons for the same month of 1962. Of the January 1963 total, 9,772,081 tons were loaded in Canada (including receipts from water carriers) as against 8,956,105 tons in January 1962. Freight received from United States rail connections destined to points in Canada declined to 740,387 tons from 752,426 a year ago, and overhead freight (United States to United States through Canada) dropped to 1,125,621 tons from 1,168,998 tons in the previous year.

Freight loadings by commodity groups showed increased tonnages in four of the six major categories. The volume of agricultural products carried rose 31.5 per cent to 2,078,843 tons from 1,581,228; less than carload freight (l.c.l.) was up 18.7 per cent to 72,041 tons from 60,705; products of mines increased 7.7 per cent to 3,364,994 tons from 3,125,068 and manufactures and miscellaneous were up 4.3 per cent to 3,123,962 tons from 2,994,540. Loadings of animals and products declined 14.7 per cent to 67,190 tons from 78,772 and forest products dropped 4.5 per cent to 1,065,051 tons from 1,115,792.

On a provincial basis, revenue freight loadings were greater in six of the ten provinces during January 1963. Manitoba's volume rose 52.4 per cent; Saskatchewan 45.3 per cent and Nova Scotia 24.7 per cent. In Quebec, rail loadings increased 15.0 per cent but this was partially due to the addition of iron ore movements by the Cartier Railway Company which commenced operations in 1962 and was included in this series of reports for the first time in August of that year. Prince Edward Island loadings rose 14.1 per cent and British Columbia recorded a 4.1 per cent increase. Decreases were reported in New Brunswick with 8.7 per cent less tonnage; Newfoundland with 7.1 per cent; and Ontario 5.6 per cent. Tonnages in Alberta were only slightly lower at 1,035,484 tons down from 1,035,880 in the same month of 1962.

Freight terminated on railway lines in Canada during the month under review totalled 11,681,101 tons, an increase of 7.2 per cent from 10,894,103 tons one year earlier. Of the 1963 total, 9,206,801 tons were unloaded at Canadian points (including deliveries to water carriers) and 2,474,300 tons were delivered to United States rail connections. This compares with 8,310,220 tons terminated in Canada and 2,583,883 tons delivered to United States rail connections in January 1962.
