OPERATING REVENUES, EXPENSES & STATISTICS ANADA RAILWAYS IN CANADA

operating revenues reported by the principal Canadian railways for December totalled \$76,285,389, down some \$1,200,000 or 1.5 p.c. from the \$77,483,355 earned in December of 1948. The current total, however, is the second highest on record for the month and includes revenues from Newfoundland operations, which are estimated at \$1,286,000. Expenses of operating were reduced from the previous December and the month's total at \$66,386,011 (including Newfoundland) was down 8.4 p.c. or \$6,073,825 from the same period of 1948. Corrections in tax accruals had shown a credit of \$3,151,666 in December of 1948, while accurals in the month under review were a debit of \$1,948,690. Hire of equipment charges increased over the preceding December and joints rent eased. The net result was an operating income for the month of \$6,663,443 compared with a revised \$6,896,898 one year previously, a decrease of some \$235,455, due entirely to the Newfoundland debit during the month, where expenses were placed at \$1,988,500.

Freight revenues declined 3.7 p.c. or \$2,270,834 to \$58,771,453 and passenger account was down 2.5 p.c. from \$7,462,746 in December of 1948 to \$7,275,041. Mail receipts eased 3.5 p.c. or \$36,873 but express improved \$258,911 or 7.7 p.c. to \$5,642,046. Other passenger train revenues advanced 6 p.c., while "all other" account climbed from \$3,773,956 to \$4,771,818, a 26.4 p.c. gain.

Operating expenses on maintenance were considerably lower at some \$25,570,000 against \$50,466,000 in the preceding December. Maintenance of equipment was down 22.6 p.c., and way and structures 7.3 p.c. Traffic expenses were up slightly but transportation eased 5.7 p.c. or \$2,067,628 to \$54,558,990. Miscellaneous and general expense accounts were heavier, the former jumping \$679,166 to \$1,728,538.

All items shown monthly under Operating Statistics (except miles of road) registered decreases from the previous December. Revenue freight tempage carried dropped 10.5 p.c. from 13,846,949 to 12,392,927 tons as pulpwood, ores, live December. Revenue freight tomrage carried dropped 10.5 p.c. from 13,846,949 to 12,392,927 tons as pulpwood, ores, live stock, implements, autos and L.C.L. merchandise shipments were reduced, and receipts from foreign connections shrank under the effects of the coal strike. Ton mileage was down 9.3 p.c. Revenue passengers numbered 2,758,180 during the month, some 362,660 less than in December of 1948. Storm conditions in the western division affected Yuletide travel and freight loadings, perticularly in British Columbia. Passenger mileage dropped 16.5 p.c. as average journey was down from 100 to 95 miles. Loaded freight car mileage was off 5.1 p.c., while empty mileage eased 9.4 p.c. Total pay roll for 174,096 employees was \$40,527,915 compared with 177,075 employees receiving \$41,398,848, including \$75,809 backtime in December of 1948. Average freight receipt per revenue ton mile was 1.293 cents compared with 1.218 cents one year earlier and average passenger receipt per mile was 2.789 against 2.386 cents.

With Newfoundland revenue and expenses included in December, 1949, CANADIAN NATIONAL RAILWAYS: With Newfoundland revenue and expenses included in December, 1949, comparisons with the previous December are somewhat affected. Total operating revenues at \$39,636,529 were up fractionally, or \$143,646 above the December of 1948, while expenses increased by \$1,479,988 or 4.5 p.c. from \$34,289,326 to Taxes, hire of equipment and joint rents were lighter. Operating income for the month at \$3,437,262 was down \$909,255. Freight revenues were 2.6 p.c. less at \$29,629,414, passanger fares were off 1.8 p.c., but express and 'all other' account registered good gains. All expense items were heavier except transportation, which declined \$753,702 or 3.7 p.c. to \$18,848,222. Maintenance charges rose 9.4 p.c. Revenue freight carried shrank 9 p.c. or 496,507 tons below the previous December to 5,036,647 tons, while ton mileage eased 7.7 p.c. Revenue passengers number 1,526,821 against 1,645,766 one year earlier, a decline of 7.2 p.c., and average journey dropped from 93 to 83 miles. Total pay roll for the nonth was \$22,252,574 received by 97,789 employees compared to \$22,717,976 going to 99,680 employees in the preceding December. The number of employees was thus down 1.9 p.c. or 1,891.

Data on United States lines of the System recorded considerable net improvement over December of 1948, with operating income of \$911,605 for the month against \$499,307. However, operating income for the System at \$4,548,867 was down from \$4,845,822 shown for December, 1948.

CANADIAN PACIFIC RAILWAY COMPANY: Total railway operating revenues were reported as \$30,115,851 for the month CANADIAN PACIFIC RAILWAY COMPANY: Total railway operating revenues were reported as \$30,115,851 for the month under review, a decrease of \$361,467 or 3.1 p.c. from the preceding December. Operating expenses were sharply reduced from \$32,845,993 by nearly 21 p.c. to \$25,995,831. Tax accruals totalled \$1,049,871 compared with an adjustment credit of \$5,911,918 in the previous December, but hire of equipment and joint rents were considerably lighter, showing credits. The net result was an improved operating income of \$3,115,673 compared with \$1,883,166 reported for December, 1948. Freight revenues dropped 4.3 p.c. or nearly \$1,062,000 to \$23,639,667 as revenue tomage carried declined 11.6 p.c., and ton mileage 11.9 p.c. Passenger revenue was down 5 p.c. to \$3,204,944 while numbers shrank 18.8 p.c. from 1,246,743 to 1,011,956. A slight increase was shown in average passenger journey from 110 to 113 miles. Revenue from mail, express, 1,011,956 and all other account registered gains. Maintenance charges were rather drastically curtailed in other passenger trein and all other account registered gains. Maintenance of way and structures was cut 32.6 p.c. or \$2,149,398 to \$4,452,901, and maintenance of equipment 36.3 p.c. from \$9,580,801 to \$6,106,607. Transportation expenses decreased 7.8 p.c. or nearly \$1,100,000 to \$13,041,500. Pay roll for the month totalled \$15,884,061, down 1.9 p.c. or \$500,929, while employees were reduced fractionally from 67,489 to 67,093 for December of 1949.
