(Financial Statistics)

Presented in this report are financial statistics of railways operating in Canada reported in accordance with the "Uniform Classification of Accounts for Class I Common Carriers by Railway". This classification, prescribed by the Board of Transport Commissioners for Canada, became effective for Class I carriers January 1, 1956 and was adopted for use by all other roads a year later.

For purposes of these accounting regulations all carriers are grouped into the following four classes:

Class I. Canadian National Railways and Canadian Pacific Railway Company.

Class II. Other carriers having average gross revenues of \$500,000 or more annually.

Class III. Other carriers having average gross revenues of less than \$500,000 annually.

Class IV. Other companies such as terminal, bridge, tunnel and pullman.

Class II, III and IV railways, exercising their option, report operating expenses in accordance with a condensed classification of accounts. Table 3 presents details of all railways on the condensed basis for purposes of comparability, while in 3A expense accounts of the C.N.R. and C.P.R. (class I) are shown separately in expanded form.

Canadian National Railways data, relative to Canadian and United States operations, previously appearing in this and other parts of the Railway Transport Report, have been discontinued with this issue due to the unavailability of a detailed breakdown of accounts. C.N.R. System financial and operating statistics covering the years 1923 to date are presented in the report entitled, "Canadian National Railways".

Earnings

Railway operating revenues in 1960, excluding those of Pullman, Tunnel and Bridge companies, totalled \$1,151,655,456, a decrease of \$72,912,472 or 6.0 per cent under that of 1959, while expenses were down \$56,836,298 or 4.9 per cent to \$1,109,470,426. The greater decline in revenues than in expenses resulted in a drop of \$16,076,174 in net operating revenues to \$42,185,030. For every

revenue dollar earned by the railways during the year under review, 96.3 cents were expended. This compares with an operating ratio of 95.2 in 1959.

Rail revenues, comprising railway, express, commercial communications and highway transport (rail) operations totalled \$1,266,881,215, down from \$1,337,580,043 in 1959. Rail expenses amounted to \$1,215,738,355 as against \$1,272,239,636 and the net rail operating income rose to \$51,142,860 from \$65,340,407.

Operating Revenues

Analysis of 1960 railway operating revenues shows decreases in all of the principal categories. Freight receipts, which were responsible for 86.2 per cent of all operating revenues, were down by \$65,270,067 to \$992,739,695 from \$1,058,009,762 thus accounting for 89.5 per cent of the total revenue drop. This reduction was partially attributable to a 4.0 per cent decline in volume of freight traffic. The average revenue per ton mile in 1960 was 1.52 cents as compared with 1.56 cents a year earlier. Passenger revenue declined 6.0 per cent to \$69,154,309 from \$73,587,794 while the revenue per passenger mile rose slightly to 3.05 cents from 3.01. Express revenue was down 5.6 per cent to \$21,779,676 from \$23,069,446 and mail revenue was off 1.4 per cent to \$17,432,364 from \$17,679,091 in 1959.

Express, commercial communications and highway transport (rail) services which are operated as separate companies or departments of the railways, produced revenues of \$58,413,486, \$52,155,661 and \$4,656,612, respectively. This compared with revenues of \$60,551,736, \$48,211,382 and \$4,248,997 in the previous year.

Operating Expenses

Although railway operating expenses also declined in 1960, the decrease failed to match the revenue loss, either relatively or in dollar amount. Road maintenance expenses were down 6.1 per cent to \$243,990,846 from \$259,958,839 due mainly to a major reduction in roadway and track maintenance costs and equipment maintenance expenses declined 2.8 per cent to \$249,473,225 from \$256,778,520. Transportation expenses, the largest of the groups, fell 4.1 per cent to \$424,924,203 from \$443,292,012 with the greatest decreases occurring in train loco-

motive fuel and power and other train locomotive expenses. All other expenses, collectively, were down 7.4 per cent.

Express operation expenses amounted to \$57,813,406 (\$59,995,579 in 1959) communications \$43,875,507 (\$41,705,267) and highway transport (rail) \$4,579,016 (\$4,232,066).

Income Account

The net rail operating income for the year ended December 31, 1960, totalled \$51,142,860, down from \$65,340,407 a year earlier. Other income in 1960 amounted to \$15,150,883 as against \$10,562,814 and fixed charges aggregated \$92,914,721 in contrast to \$76,111,172. The resulting rail loss for the year under review was \$26,620,978 as compared with a deficit of \$207,951 the previous year.

Tax Accruals

Railway taxes at \$59,962,779 in 1960 were slightly lower than the \$60,221,144 reported a year earlier. Provincial taxes totalled \$2,959,295 versus

\$2,512,173 and municipal taxes rose \$850,642 to \$16,142,309 from \$15,291,667. Income and excise taxes declined 8.6 per cent from the previous year while unemployment insurance and other special taxes were somewhat higher.

Capitalization

Railway capital at the close of 1960 stood at \$4,970,399,496, up \$179 million from \$4,791,737,482 in 1959. The value of outstanding capital stock increased to \$2,725,827,684 from \$2,669,062,269 and bonded debt rose to \$1,978,534,587 from \$1,698,811,553. Miscellaneous funded debt was reduced to \$223,266,225 from \$370,932,660 and equipment trust obligations declined to \$42,771,000 from \$52,931,000.

Current Assets and Liabilities

Current assets totalled \$430,603,115 in 1960 as compared with \$422,635,143 in 1959 and current liabilities dropped to \$191,040,001 from \$220,165,087.
