

(Financial Statistics)

Presented in this publication are financial details of railways operating in Canada reported in accordance with the, "Uniform Classification of Accounts for Class I Common Carriers by Railway". This classification was prescribed by the Board of Transport Commissioners for Canada and became effective for Class I carriers January 1, 1956 and for all other common carrier railways a year later.

For purposes of these accounting regulations all railways are grouped into the following four classes:

Class I. Canadian National Railways and Canadian Pacific Railway Company.

Class II. Other carriers having average gross revenues of \$500,000 or more annually.

Class III. Other carriers having average gross revenues of less than \$500,000 annually.

Class IV. Other companies such as terminal, bridge, tunnel and pullman.

Under the above-noted uniform accounting system, Class II, III and IV companies are permitted to use a condensed classification of expenses provided for their respective classes. In Table 3 of this report, expenses for all railways are presented on this basis, while in Table 3A accounts of the C.N.R. and C.P.R. are shown separately in expanded form.

Financial Results

Railway operating revenues in 1961, which were augmented by \$50.0 million in interim payments from the Federal Government, related to recommendations of the Royal Commission on Transportation, were up \$4.8 million to \$1,156.5 million from \$1,151.7 million in 1960. Operating expenses rose nearly \$4.9 million to \$1,114.4 million from \$1,109.5 million, and net operating revenues for the industry aggregated \$42.0 million in contrast to \$42.2 million a year earlier. For every revenue dollar earned by the railways during the year under review, 96.4 cents were expended. This ratio remained virtually unchanged from the previous year.

Rail revenues, which comprises railway, express, commercial communications and highway transport (rail) operations, totalled \$1,277.2 million, up from \$1,266.9 million in 1960. Rail expenses increased to a greater degree, rising to \$1,227.6 million from \$1,215.7 and as a result, the net operating income declined to \$49.6 million from \$51.1 a year earlier.

Operating Revenues

Freight revenues, in which the \$50.0 million interim payments relating to the Royal Commission on Transportation were included, totalled \$1,013.0 million in 1961, up from \$992.7 million. The average revenue per ton-mile of freight in 1961 was 1.54 cents as compared with 1.52 cents a year earlier. Passenger revenues, at \$61.2 million, were \$7.9 million or 11.5 per cent below 1960, while the revenue per passenger mile rose to 3.12 cents from 3.05. Mail receipts were down 3.0 per cent and express revenues dropped 26.0 per cent from the previous year. The latter account includes amounts received or due the railways for Canadian services rendered to express organizations; the privilege of conducting business over Canadian rail lines; and the use of Canadian rail facilities by express organizations.

Revenues of express organizations, which are operated as separate companies or departments of the railways, totalled \$60.5 million in 1961, up from \$58.4 million the previous year. Included therein were amounts from operations pertaining to Canadian rail transportation services, from haulage, cartage, pick-up and delivery, and financial operations. Commercial communications, and highway transport (rail) services produced revenues of \$55.2 million and \$5.1 million, respectively. This compared with \$52.2 million and \$4.7 million in 1960.

Operating Expenses

Despite increased wage costs of \$1.4 million during 1961, road maintenance expenses declined to \$243.4 million from \$244.0 million in 1960. The reduction was due mainly to a \$3.1 million decrease in track maintenance costs which were down to

\$21.9 million from \$25.1 million. Equipment maintenance expenses were down slightly from the year earlier level, aggregating \$249.4 million in contrast to \$249.5 million. The largest reduction was recorded in car maintenance expenses, while increases occurred in depreciation charges and labour costs. Transportation expenses, the largest of the general accounts, declined \$1.6 million to \$423.4 million from \$424.9 million in 1960. The wage bill for trainmen and train enginemen was somewhat lower during 1961, dropping \$2.2 million and \$1.6 million, respectively. Savings were also registered during the year in train locomotive fuel and power (\$1.8 million) and in other train locomotive expenses (\$1.4 million). Other rail transportation costs rose by \$7.0 million mainly as a result of higher rail communication system expenses. All other operating expenses, collectively, were up \$7.2 million over the year 1960.

Express, commercial communications and highway transport (rail) services operating expenses in 1961 totalled \$60.0 million (\$57.8 million in 1960); \$48.6 million (\$43.9 million); and \$4.6 million (\$4.6 million), respectively.

Income

Taking into account other income of \$8.6 million and fixed charges totalling \$85.5 million the

end result in 1961 was an overall rail deficit of \$27.4 million. This compared with a loss of \$26.6 million in 1960. Non-rail operations, such as steamship services, public stockyards, hotels, etc. netted the railways a further loss of \$2.4 million in 1961 (\$2.0 million in 1960).

Tax Accruals

Taxes in the year under review aggregated \$61.3 million in contrast to \$60.0 in 1960. Provincial taxes totalled \$2.7 million in 1961 as against \$3.0 million a year earlier while municipal taxes rose to \$16.7 million from \$16.1 million. Income and excise taxes increased to \$33.6 million from \$31.9 and unemployment insurance at \$6.6 million was double that of the previous year. Other special taxes declined to \$1.7 million from \$5.7.

Capitalization

Railway capital at the close of 1961 stood at \$4,982.9 million, up from \$4,970.4 million in 1960. The value of outstanding stock increased to \$2,748.5 million from \$2,725.8 while bonded debt declined to \$1,957.1 million from \$1,978.5 million. Miscellaneous debt rose to \$243.7 million from \$233.3 million and equipment trust obligations dropped to \$33.5 million from \$42.8 million.


