

PREFACE

Annual railway transport statistics in Canada are published in a series of six reports each of which covers specific aspects of the industry; services and equipment available, traffic handled, the labour force involved and the financial aspects of railways operating in this country.

Statistics on railways have been collected and published in Canada since 1875, first by the Department of Railways and Canals until 1918, and by Statistics Canada since its inception in 1918. During this time the data have been published in varying degrees of detail. Until 1950 one volume contained all railway statistical data. In 1951 there were three; 1952-1957 there were five, and since 1958 six separate parts have been required to reflect these annual operations. The present report encompasses the following six parts which are not necessarily released in the order they are numbered.

- Part I. Railway Transport – Summary Statistics (Five years)
- II. Railway Transport – Financial Statistics
- III. Railway Transport – Equipment, Track and Fuel Statistics
- IV. Railway Transport – Operating and Traffic Statistics
- V. Railway Transport – Commodity Statistics
- VI. Railway Transport – Employment Statistics

Several other annual reports and three periodicals dealing with rail transportation are also available. A list of all titles published in this field is located on the outside back cover of each report.

Statistics Canada is indebted to the individual railway companies operating across the nation which have prepared and submitted their data for inclusion in this statistical series; to the Railway Association of Canada for its cooperation; and to the Railway Transport Committee of the Canadian Transport Commission, with which joint collection arrangements exist, for their promotion of the uniform accounting principles used for rail statistical purposes.

This report has been prepared by the Transportation Section of the Transportation and Public Utilities Division of Statistics Canada. Any inquiries or comments respecting data contained herein, or to unpublished detail, should be forwarded to this Section.

INTRODUCTION

Coverage and Technical Background

This publication presents financial details of common carrier railways operating in Canada reported in accordance with the "Uniform Classification of Accounts for Common Carriers by Railway" prescribed by the Railway Transport Committee, Canadian Transport Commission.

For purposes of these accounting regulations, railways are grouped into the following four classes:

Class I—Canadian National Railways and the Canadian Pacific Railway Company.

Class II—Other carriers having average gross revenues of \$500,000 or more annually from Canadian rail transportation operations.

Class III—Other carriers having average gross revenues of less than \$500,000 annually from Canadian rail transportation operations.

Class IV—Other railways such as terminal, bridge, and tunnel companies.

Class II, Class III and Class IV carriers have the option of using a condensed classification of expenses provided for them. In Table 3 operating expenses for all railways are presented on this condensed basis for purposes of comparison, while in Table 3 A, accounts of the CNR and CPR are shown separately in more detail.

A "common carrier", as referred to in this series refers to one which holds itself out to the general public to transport passengers and/or goods for compensation.

Data is shown separately for only those individual railways having gross operating revenues of \$8 million or more annually. These roads account for over 96½ per cent of gross railway operating revenues in Canada.

Not included in this publication are financial data in respect of the Cartier Railway Company in Northern Quebec. Included for the first time are data pertaining to "GO" Transit commuter operations.

While transportation and traffic statistics of the Cartier Railway Company are included in material appearing in Parts III, IV and V of this annual series, financial details relative to their railway operations are not available and thus do not appear herein or in Part VI.

In order to define the scope of any given industry and avoid the overlapping of different publications covering two or more closely related industries, Statistics Canada uses the *Canadian Standard Industrial Classification (S.I.C.)*, Catalogue 12-501, which provides a set of groups and classes suitable for the compilation of statistics

related to different industries. The building block (reporting unit) which is fitted into the above structure is the "establishment". An establishment can be defined as the smallest unit which is a separate operating entity capable of reporting principal elements of input and output. While the establishment is typically a factory, mine, store or similar unit and in most cases is a separate firm, it may encompass two or more operating units which are not necessarily in the same location. It can also be an individual working on his own account.

Industry 503 (formerly 506), Railway Transport, as classified in the S.I.C. Includes establishments primarily engaged in operating railways. The kinds of activities normally carried on by railway establishments embraces the operation of freight and passenger trains, commuter service (but not street railways) maintenance of way and structures, maintenance of equipment, (including that carried on in railway shops) dining car and sleeping car services, freight, express and the operation of railway terminal facilities. Road transportation services operated by railway establishments and providing pick-up and delivery for the freight or express services of the railway are included in this industry but long distance trucking operations owned by railway companies are usually treated as separate establishments classified to the trucking industry and included under S.I.C. Industry 507, Truck Transport.

Commercial communications facilities providing service to the general public as well as to the railway are treated as separate establishments and included in S.I.C. Industries 544 Telephone Systems and 545 Telegraph and Cable Systems.

Highway transport (rail) covers only certain highway movements which are deemed to form an integral part of a railway haul. Thus a railway may offer a service on a single ticket or rate to a northern point some distance from the railhead and provide bus or truck transport to destination with its own equipment. Most railways however merely turn such traffic over to independent highway carriers in an arm's length transaction.

Overall Financial Results

Total operating revenues of all common carrier railways in Canada, excluding the Cartier Railway as noted above, totalled a record \$1,679,759,268 in 1970, up 5.9 per cent from 1969. Since GO Transit is now included in this report, 1969 figures have been restated to include GO Transit figures where required for comparative purposes. By comparison Canada's gross national product in current dollar terms showed an increase of 7.5 per cent over the same period.

Total railway operating expenses rose 4.8 per cent to \$1,573,578,729 leaving net railway operating revenues (after rents and taxes but before fixed charges) up 23.5 per cent at \$106,180,539.

Net rail income after taking into account express, communications and highway transport (rail) operations plus fixed charges, interest income etc., rose 80.5 per cent to \$33,650,657. Non-rail operations (steamships, hotels, investments, etc.) of these companies however did not fare so well in 1970 as net income dropped 88.5 per cent to \$2,126,009, leaving overall net income down 3.6 per cent at \$35,776,666. The decline in non-rail net income was largely attributable to losses incurred by Canadian National in this area.

Operating Revenues

Freight revenues, excluding payments related to the National Transportation Act¹ rose \$104.7 millions or 7.9 per cent to \$1,436.0 millions in 1970. The average amount of revenue received by the railways in 1970 for hauling a ton of freight one mile was 1.30 cents compared to 1.38 cents in 1969. Passenger revenues (including GO Transit) declined \$2.2 millions or 3.4 per cent to \$63.7 millions. Revenue per passenger-mile rose to 2.80 cents from 2.73 cents in 1969.

¹ Under the National Transportation Act of 1967 a number of specific subsidies for services provided in the national interest were replaced by payments to the railways of transitional subsidies, or "normal payments", beginning in 1967 and continuing in diminishing amounts each year until 1974. Such payments in 1967 aggregated \$108.9 million while in 1968 they were reduced to \$95.1 million in 1969 to \$81.3 million, and in 1970 to \$67.4 million.

It is notable that all of the largest nine roads for which data is shown separately recorded increases in total railway revenue, with Quebec North Shore and Labrador up the most sharply due largely to the adverse effects of a mining strike on their 1969 revenues.

Operating Expenses

The increase of \$72.8 millions in total railway expenses may be attributed mainly to increases of \$26.7 millions in Transportation Expenses, \$19.7 millions in Equipment Maintenance, \$9.5 millions in Road Maintenance and \$9.0 millions in Tax Accruals. All major categories of expenses posted gains except Miscellaneous Railway Operations which recorded a decline of \$1.5 millions.

Retained Earnings and Assets

The retained income account showed a rise of \$9.5 millions during the year to \$808.5 millions at December 31, 1970. Dividend appropriations rose \$9.6 millions to \$65.5 millions in 1970.

Total assets at year end came to \$10,182 millions, a rise of 2.8 per cent over the total at December 31, 1969. This increase was mainly a reflection of higher investment in road and equipment property. The corresponding increases in liabilities occurred mainly in depreciation reserves and in capital stock outstanding.


