## INTRODUCTION

As of 1960, the information formerly contained in the annual publications "The Motor Vehicle"—Catalogue No. 53-203 and the "Motor Vehicle—Preliminary Report of Registrations and Size, Weight and Safety Regulations"—Catalogue No. 53-204 has been consolidated into one annual report to be called "The Motor Vehicle". This new report is to be produced in four separate parts as follows:

Part I — Rates and Regulations.....	53-217
Part II — Motive Fuel Sales .....	53-218
Part III — Registrations .....	53-219
Part IV — Revenues .....	53-220

Part I—"Rates and Regulations" contains all information available regarding commercial motor vehicle regulations; tax and licence fee rates, reciprocal highway agreements; size, weight and safety regulations and an historical gasoline tax review, by provinces.

Part II—"Motive Fuel Sales" contains gross and net sales of gasoline and net sales of diesel oil, by provinces.

Part III—"Registrations" includes provincial registrations of the main classes of motor vehicles; an historical table of total registrations and registrations, by municipality and county.

Part IV—"Revenues" shows provincial government revenues from the main classes of motor vehicles and from motive fuel taxes and the financial operations of unsatisfied judgment funds.

### Registrations

Table 1 is an historical summary showing the increase in registrations by provinces since 1903 when Ontario became the first province to establish a requirement for the registration of motor vehicles.

All motor vehicles which are licensed to operate on the public highways are included in Table 2 "Registrations of Motor Vehicles, Drivers, etc.". Motorcycles, including motor bicycles, are classified as motor vehicles. Trolley coaches are registered as motor vehicles in Nova Scotia, Quebec and Ontario, but for licensing purposes Quebec does not distinguish them from motor buses. In other provinces trolley coaches do not require provincial motor vehicle licences. "New" registrations are defined as vehicles registered for the first time in the reporting province and include used as well as new vehicles.

Provincial licensing laws vary considerably on the definition of gasoline stations and garages. These refer not only to service stations which sell gasoline and garages which engage in the task of repairing motor vehicles but also to other outlets. For example, Ontario lists as a retail outlet any place having (a) a gasoline pump and (b) a licence to sell gasoline, while British Columbia includes new car dealers selling gasoline. In Ontario and British Columbia the group "Garages" includes establishments which do not perform automotive repair work such as used car lots, storage for vehicles, parking lots etc.

Some differences in the presentation of data for Ontario and British Columbia from prior years should be noted. Station wagons and similar vehicles which in previous reports had been included with commercial vehicles in Ontario are now included with passenger automobiles. There were 92,587 station wagons registered in Ontario in 1960. In British Columbia station wagons, prior to 1960, were included with either passenger automobiles or commercial vehicles depending on the licence bought. Due to the change in the licensing system in 1960 station wagons are now all included with passenger automobiles.

These changes with regard to the appropriate place to include data on station wagons has affected year to year comparisons of registrations in these provinces and also the total for Canada. Fortunately

it has been possible to revise Ontario data for past years to make them comparable with 1960, however, no such revision was possible for British Columbia.

Motor vehicles licensed during the 1960 registration year increased 4.8 p.c. to 5,256,341 from 5,017,686 in 1959. Passenger car registrations were 4,104,415, 5.6 p.c. higher than the 3,886,436 licensed in the previous year, while registrations of commercial vehicles increased 1.9 p.c. to 1,117,450 from 1,097,083. Motorcycles, including motor bicycles, increased to 34,476 from 34,167 in 1959.

At the end of the 1960 registration year there were ten motor vehicles registered for every 34 Canadians. Alberta has the largest number of motor vehicles in relation to population, with ten for every 26 persons. For passenger cars only there were 10 to every 43 Canadians. Ontario had the largest number of passenger cars in relation to population at ten per 35 persons. All regions, with

the exception of Nova Scotia, showed increases over the previous year in the number of vehicles per capita.

Gains in total registrations occurred in all provinces except Nova Scotia, ranging from a low of 2.6 p.c. in Saskatchewan to a high of 21.1 p.c. in Newfoundland. It should be borne in mind, however, that Newfoundland data in 1959 was available for the period April 1 to September 30 only.

In Table 4 the totals represent the number of vehicles registered in each of the cities, counties, etc. according to the home address of owner. Prior to the 1957 report, the totals for all provinces except Manitoba, Saskatchewan and Alberta represented the number of licences issued by each issuing office in the particular areas listed.

Through the courtesy of the Motor List Company of Toronto these data are now on a comparable basis for all provinces reported in this issue.

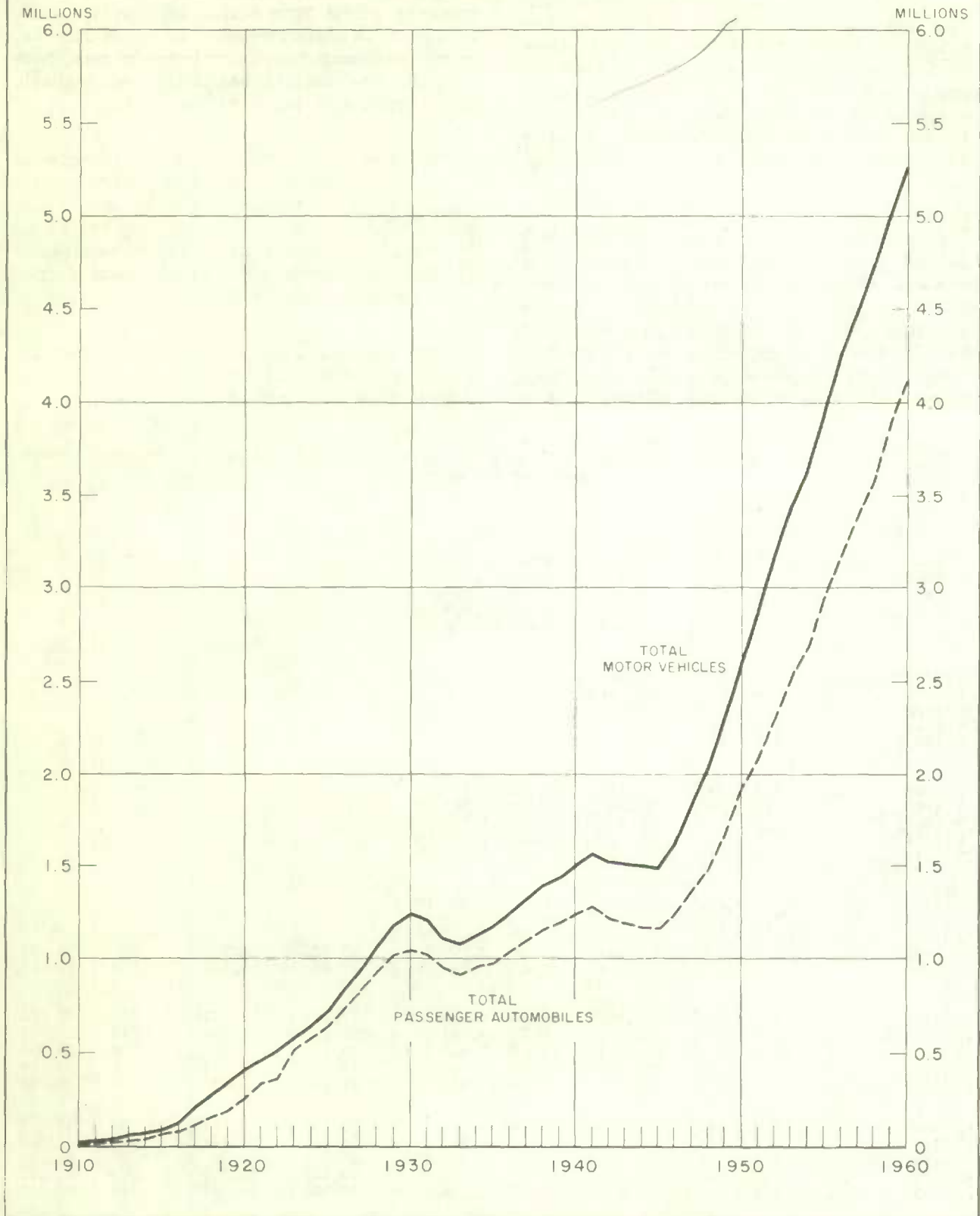
