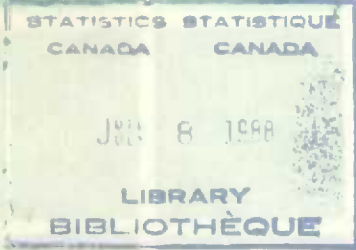

## HIGHLIGHTS

### Capacity

- o Total generating capacity in Canada at the end of 1986 amounted to 100 074 036 kW, 3.1% more than the total of 97 019 369 kW in 1985. Utilities accounted for 93 919 722 kW compared with 90 901 825 kW in 1985 while industry had a capacity of 6 154 314 kW up from 6 117 544 kW.
- o The publication **Electric Power Statistics, Volume III - Inventory of Prime Mover and Electric Generating Equipment** (Catalogue 57-206) gives additional details on generating stations.

### Generation

- o Net generation (total generation less energy used in generating station service) increased 2.2% in 1986 to 457 006 873 MW.h from 447 181 814 MW.h one year earlier. Generation by electric utilities (91.7% of the total) increased 2.5% to 419 155 729 MW.h from 408 831 244 MW.h. Generation by industry decreased 1.3% to 37 851 144 MW.h from 38 350 570 MW.h.

### Sales

- o Total sales of electricity to ultimate customers increased 11.9% to 350 133 913 MW.h from the 1985 total of 312 773 574 MW.h.
- o A 2.4% rise in the average number of ultimate customers brought the total to 10,975,951 from 10,720,714 in 1985.
- o Revenue received from sales to ultimate customers totalled \$14,852,654,000 up 10.5% from the 1985 total of \$13,436,822,000.

### Cost of Fuels

- o Electric utilities reported an expenditure of \$1,634,010,000 on fuel for thermal electric plants in 1986, a decrease of 12.2% from the \$1,861,914,000 reported one year earlier. The amount spent on oil decreased 33.2% to \$228,890,000 from \$342,522,000 while that on natural gas decreased 35.8% to \$32,746,000 from \$50,998,000. At the same time expenditure for coal decreased 13.7% to \$1,034,058,000

## FAITS SAILLANTS

### Puissance génératrice

- o La puissance génératrice totale au Canada à la fin de 1986 était de 100 074 036 kW, soit, 3.1% de plus qu'en 1985 (97 019 369 kW). De ce chiffre, les services avaient 93 919 722 kW contre 90 901 825 kW en 1985 et l'industrie 6 154 314 kW ce qui représente une hausse par rapport au 6 117 544 kW de l'année précédente.
- o La publication **Statistique de l'énergie électrique, volume III - Inventaire des moteurs primaires, et des générateurs électriques** (n° 57-206 au catalogue) contient d'autres renseignements sur les centrales.

### Production

- o La production nette (production totale moins l'énergie pour l'entretien de la centrale) a augmenté de 2.2% en 1986 atteignant 457 006 873 MW.h comparativement à 447 181 814 MW.h en 1985. La production des services est passée de 408 831 244 MW.h à 419 155 729 MW.h (+2.5%), ce qui représente 91.7% de la production totale. La production de l'industrie a diminué de 1.3% avec 37 851 144 MW.h contre 38 350 570 MW.h.

### Ventes

- o Les ventes totales d'électricité aux abonnés ultimes ont augmenté de 11.9% atteignant 350 133 913 MW.h comparativement à 312 773 574 MW.h en 1985.
- o Une augmentation de 2.4% du nombre moyen d'abonnés ultimes a fait passer le total de 10,720,714 à 10,975,951.
- o Les recettes provenant des ventes aux abonnés ultimes ont atteint \$14,852,654,000 soit 10.5% de plus qu'en 1985 (\$13,436,822,000).

### Le coût du combustible

- o Les services d'électricité ont déclaré des dépenses de \$1,634,010,000 en combustible pour les centrales thermiques en 1986 ce qui représente une diminution de 12.2% par rapport à \$1,861,914,000 en 1985. Le montant dépensé pour les combustibles pétroliers a diminué de 33.2% se chiffrant à \$228,890,000 comparativement à \$342,522,000 tandis que le coût pour le gaz naturel, a diminué de 35.8% atteignant \$32,746,000 (\$50,998,000 en 1985). Dans la même

from \$1,197,687,000. Imported coal cost \$443,693,000; 42.9% of the total expenditure for coal compared with 45.7% in 1985.

- o It should be noted that the values presented above which have been taken from Table 7 may differ considerably from those appearing in Table 9. The differences are a result of timing, e.g. annual (Table 7) and fiscal (Table 9) and accounting procedures, e.g. royalties paid on coal production are included in Table 7 which are a separate item in Table 9.

#### Financial Data

- o Wages and salaries paid by the electric utility industry amounted to \$2,701,568,000 in 1986; with publicly operated utilities reporting a total of \$2,546,660,000 and privately-operated utilities \$154,908,000.
- o Total assets (after depreciation) of the electric utility industry stood at \$94,319,173,000 compared with \$90,928,445,000 one year earlier, an increase of \$3,390,728,000 or 3.7%.
- o Operating revenues of electric utilities rose 4.1% in 1986 increasing to \$20,555,990,000 from \$19,753,846,000. Operating expenses rose to \$12,779,017,000 from \$12,386,141,000 an increase of 3.2%.

période, les dépenses pour le charbon ont diminué de 13.7% (\$1,034,058,000 comparativement à \$1,197,687,000); le charbon importé a coûté \$443,693,000; 42.9% des dépenses totales pour le charbon comparativement à 45.7% en 1985.

- o Il est à noter que les valeurs présentées ci-haut, en provenance du Tableau 7, peuvent être considérablement différentes de celles apparaissant au Tableau 9. Les différences sont dues à la période considérée i.e. sur la base du calendrier pour le Tableau 7 et basée sur l'année fiscale pour le Tableau 9, ainsi qu'une différence dans les procédures comptables i.e. les royalties payées sur la production du charbon sont incluses au Tableau 7 mais sont considérées séparément dans le Tableau 9.

#### Données financières

- o Les rémunérations versées par les services d'électricité ont atteint \$2,701,568,000 en 1986; les services publics ayant versé un montant de \$2,546,660,000 et les services privés \$154,908,000.
- o L'actif total (après amortissement) des services d'électricité a atteint \$94,319,173,000 comparativement à \$90,928,445,000 un an plus tôt, ce qui représente une augmentation de 3.7% (\$3,390,728,000).
- o Les recettes d'exploitation des services d'électricité ont augmenté de 4.1% en 1986, atteignant \$20,555,990,000 comparativement à \$19,753,846,000. Les dépenses d'exploitation aussi ont augmenté; elles sont passées de \$12,386,141,000 à \$12,779,017,000 (+3.2%).

## Notes

This publication includes statistics for Industry 491 - Electric Power of the **Standard Industrial Classification Manual** (Catalogue 12-501) as well as commodity statistics for industrial establishments with generating facilities.

Table 3 has undergone two major changes for 1986.

The first of these involves the amount of energy received by industrial generators from utilities. In past years all receipts were recorded, but starting in 1986 only those receipts necessary to fulfil outside commitments are shown; consequently the line "Used by producers" has been greatly reduced as it represents only that energy "used" from own production. This reduction is balanced by an equal increase in utility sales to mining and manufacturing. Table 11 is not affected.

The second change relates to sales to agriculture. Due to the problems encountered by the reporting utilities (no standardization of the definition of a "farm" for those having a farm rate; for those without a farm rate, coding of farm customers has not been undertaken or is incomplete) estimates have been made based on the 1986 Census of Agriculture and utility data. Only farms with a gross income of more than \$5,000 are included. Commensurate changes to "Residential" have also been included. Tables 4 and 11 also reflect these revisions.

The consumption categories employed in this publication do not equate with the rate structures of the utilities. Respondents have been requested to classify their customers according to these consumption categories. Because of the ongoing nature of the task of upgrading the accuracy of this classification, there may be a certain lack of uniformity in these statistical series through time.

## Nota

La présente publication contient des statistiques sur le sous-groupe 491 - Énergie électrique du manuel de la **Classification des activités économiques** (n° 12-501F au catalogue) de même que des statistiques sur l'électricité pour les établissements industriels pourvus d'installations électrogènes.

Le tableau 3 a encouru deux changements majeurs en 1986.

Le premier changement concerne le montant d'énergie reçu par les producteurs "industriel" en provenance des producteurs dits "de services". Par le passé, toutes les réceptions étaient enregistrées, mais commençant en 1986, seulement les réceptions nécessaires à remplir les engagements extérieurs sont rapportées; conséquemment la ligne "Utilisée par les producteurs" a été grandement réduite car elle représente seulement l'énergie "utilisée" provenant de sa propre production. Cette réduction est balancée par une augmentation égale dans les ventes des producteurs dit "de service" aux secteurs miniers et manufacturiers. Le tableau 11 n'est pas touché.

Le second changement touche les ventes au secteur agricole. À cause des difficultés encourues par les répondants du secteur de service (aucune standardisation de la définition d'une "ferme" pour ceux qui ont un taux d'imposition basé sur cette définition; pour ceux qui ne l'ont pas, soit que la codification des fermes n'a jamais été faite ou est incomplète) des estimations ont été faites en se basant sur le recensement de l'agriculture de 1986 et les données des services. Seulement les fermes qui ont un revenu brut supérieur à \$5,000 sont incluses. Conséquemment, les changements au secteur "résidentiel" ont également été inclus. Les tableaux 4 et 11 reflètent ces révisions.

Les catégories de consommateurs employées dans cette publication ne correspondent pas avec la structure de tarification des distributeurs d'électricité. Il a été demandé aux répondants de classer leurs clients selon les catégories de consommateurs présentées. À cause des révisions en cours afin d'améliorer la précision de cette classification, il peut y avoir quelques problèmes de consistance dans certaines séries chronologiques.

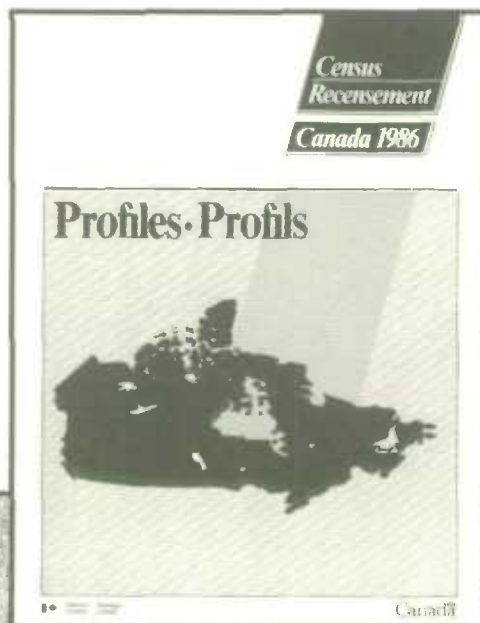
