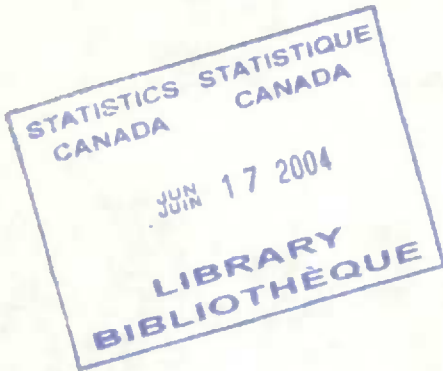

CORPORATION PROFITS

FOURTH QUARTER 1967

The estimates of corporation profits and other financial data contained in this report are the results of a sample survey of all companies incorporated in Canada, except Government-owned companies. Canadian unincorporated branches of foreign corporations are also included in the totals while foreign subsidiaries of Canadian corporations are excluded.

Sources and Methods

In preparing the estimates, a stratified random sample of corporations is used together with the summary corporation statistics contained in "Taxation Statistics" published by the Department of National Revenue (Taxation Division). The figures in "Taxation Statistics" are on an annual basis and are available about two years after the year to which they refer. The sample results are used to allocate the annual totals by quarters, and current figures are obtained by projection from this base. This procedure ensures that profits are defined consistently for all corporations and improves the accuracy of the estimates.

Under the original design of the sample, estimates of profits would be within 3 per cent of the "true" figures 95 per cent of the time. However, since not all companies in the original sample are participating in the survey, the actual error is about 6 per cent. This error will be reduced as the number of companies in the sample increases.

Definitions

The definitions of items contained in the report are based mainly on accounting definitions used by corporations. The term "profits" as used throughout this report means the total profits of all companies earning profits less the losses of all companies incurring losses.

Sales figures in "Taxation Statistics" are used as a base for projecting the estimates obtained from

the survey to provide current sales estimates. These sales figures contain investment income as well as income from operations.

Net earnings as used in this report are the total earnings, exclusive of Canadian dividends received, after all current charges except depletion, capital cost allowance, charitable donations and income tax liabilities. Canadian dividends received are excluded because earnings are computed before payment of dividends, and if receipt of these dividends were included they would be counted twice, once in the hands of the paying corporation and again in the hands of the receiving corporation.

Depletion charges are not deducted since, although these are properly a charge for individual firms, the exhaustion of natural resources should not be a charge against National Income. However, for the three groups for which depletion charges are significant—mining, wood products and paper products—depletion charges are shown separately in the tables.

Capital cost allowance as outlined in the tables reflects the amount of depreciation claimed for income tax purposes, and, therefore, may not be comparable to the amounts as shown by corporations in their own books.

Income tax liabilities are based on figures supplied by reporting companies.

Depletion charges are based on the amounts reported by the companies and are not related to the data contained in "Taxation Statistics".

A more comprehensive description of the methods, sources and definitions is contained in the initial publication of this series, "Quarterly Corporation Profits, 1950-1954", issued by the Dominion Bureau of Statistics in March, 1955.

NOTE

The data contained in Tables 1 to 5 inclusive of this report have been revised to take into account the latest available information for previous periods and, therefore, replace the estimates in earlier issues for the years 1964 to date. All data from the first quarter of 1964 to the third quarter of 1967 inclusive have been reworked to make use of more up-to-date information.

Corporation Profits - Fourth Quarter, 1967

Seasonally-adjusted corporation profits before taxes are estimated at \$1,309 million for the fourth quarter of 1967, an increase of \$22 million or 1.7 per cent from the revised 1967 third quarter estimates of \$1,287 million.

In the Manufacturing sector, profits increased by \$37 million or 6.6 per cent, from a revised \$561 million in the third quarter to \$598 million in the fourth quarter. The most marked increase occurred in the Rubber Industries where profits rose by \$7 million or 77.8 per cent from \$9 million to \$16 million. Other marked increases were as follows: Electrical Products Industries, \$8 million or 30.8 per cent from \$26 million to \$34 million; Textile Industries, \$4 million or 26.7 per cent from \$15 million to

\$19 million; Other Manufacturing Industries, \$4 million or 13.8 per cent from \$29 million to \$33 million; Chemical and Chemical Products Industries, \$5 million or 10.6 per cent from \$47 million to \$52 million; the Metal Industry including four major groups - Primary Metal, Metal Fabricating, Machinery and Transportation Equipment, \$14 million or 7.7 per cent from \$182 million to \$196 million and Petroleum and Coal Products Industries, \$3 million or 7 per cent from \$43 million to \$46 million. Wood Industries rose slightly by \$1 million or 3.7 per cent from \$27 million to \$28 million. Partly offsetting the increase occurring in the aforementioned industries was a sizeable decrease in the Non-metallic Mineral Products Industries of \$3 million or 21.4 per cent to \$11 million from \$14 million followed by

other declines in the Paper and Allied Industries, \$3 million or 8.8 per cent to \$31 million from \$34 million and Food and Beverage Industries, \$3 million or 2.9 per cent to \$102 million from \$105 million. Printing, Publishing and Allied Industries remained unchanged at \$30 million.

The Non-manufacturing sector, in total, decreased by \$15 million or 2.1 per cent to \$711 million in the fourth quarter of 1967 from \$726 million in the third quarter of 1967. Within this sector, four industries showed a decline while the four others showed an increase. Retail Trade decreased substantially by \$23 million or 23.7 per cent to \$74 million from \$97 million; Service Industries dropped by \$9 million or 18.4 per cent to \$40 million from \$49 million; Electric Power, Gas and Water Utilities decreased slightly by \$1 million or 3.3 per cent to \$29 million from \$30 million and Finance, Insurance and Real Estate showed a minor decrease of \$2

million or 1.1 per cent to \$181 million from \$183 million. The industries recording a rise are: Other Non-Manufacturing, \$3 million or 15.8 per cent from \$19 million to \$22 million; Transportation, Storage and Communication, \$5 million or 4.9 per cent from \$103 million to \$108 million; Wholesale Trade, \$4 million or 4 per cent from \$100 million to \$104 million and finally, Mines, Quarries and Oil Wells, \$8 million or 5.5 per cent from \$145 million to \$153 million.

Comparing with the revised fourth quarter estimates of 1966, profits for all industries increased by \$24 million or 1.9 per cent from \$1,285 million to \$1,309 million. The Manufacturing sector recorded an increase of \$40 million or 7.2 per cent from \$558 million to \$598 million while the Non-manufacturing sector showed a decline of \$16 million or 2.2 per cent to \$711 million from \$727 million.
