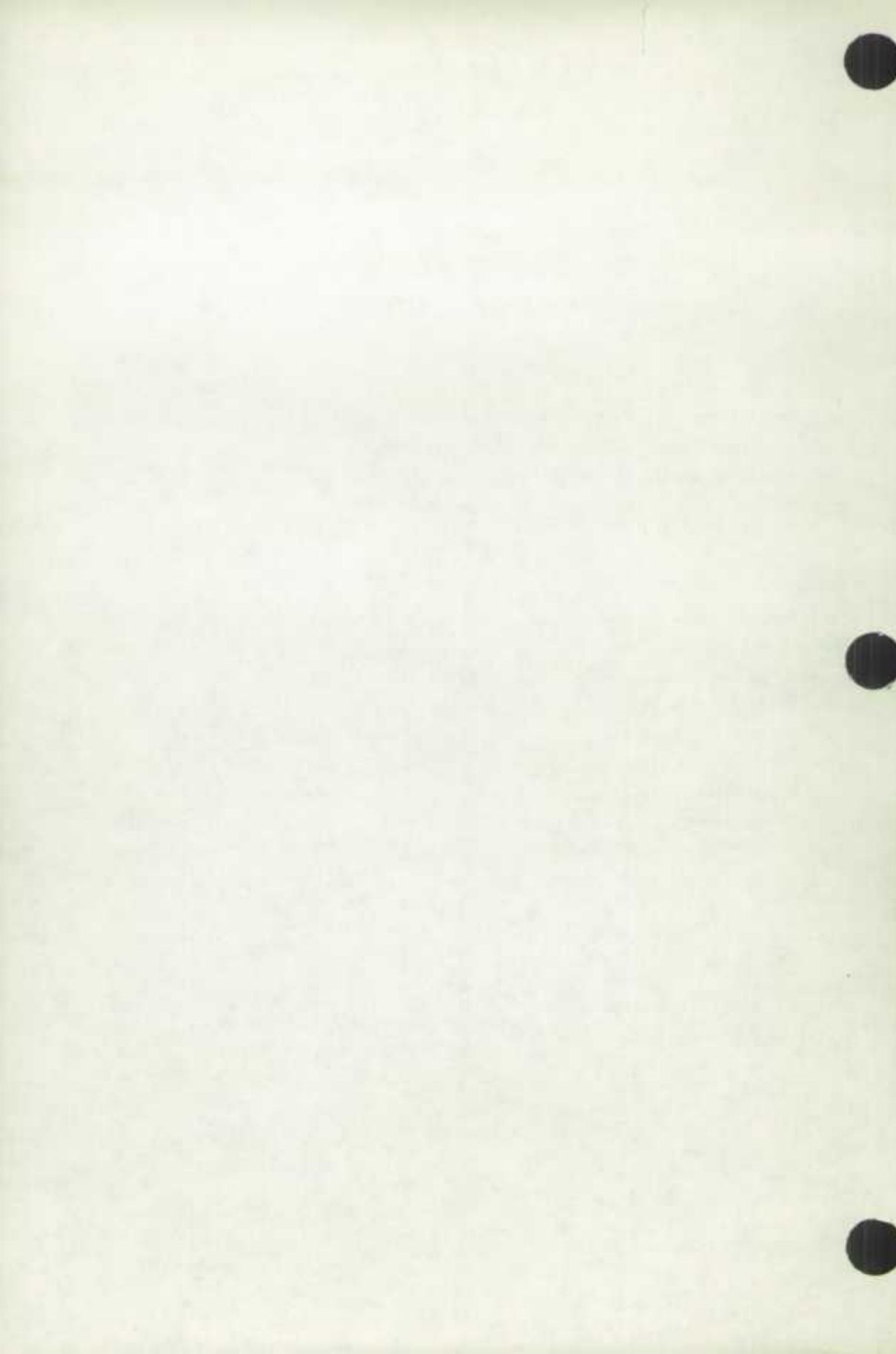

SECTION I. RE-APPRAISAL OF THE 1969 CAPITAL EXPENDITURES PROGRAMME

The results of a recent DBS survey during May and June have indicated that \$17,356 million of capital expenditures by all sectors of the Canadian economy are being planned for 1969. This total represents an increase of 1.8 per cent over the total of \$17,046 million of intended capital outlays reported at the beginning of 1969 in "Private and Public Investment in Canada, Outlook 1969" (Catalogue No. 61-205). The new level for the year is 10.7 per cent higher than the preliminary estimates of \$15,678 million for 1968.

The latest survey covered business establishments, institutions and all levels of government with respondents being asked to report any revisions to their estimates of intended capital spending during 1969. Estimates of expected repair expenditures were not reviewed and therefore the figures for repairs shown in the following tables are the same as those appearing in the earlier report.

The expected further increase in capital spending in the current year is reflected in the totals for both residential and non-residential types of construction but not in the estimates of purchases of new machinery and equipment. Expenditures on all new construction in 1969 are now expected to amount to \$11,384 million, about 3 per cent higher than the earlier estimate of \$11,034 million for 1969 and about 12 per cent above the 1968 level of \$10,136 million. The latest total for machinery and equipment, at \$5,972 million, is only marginally lower than the first estimate of \$6,012 million and 8 per cent over the \$5,542 million for 1968.

Most industry groups in the business sector show further increases with the exception of agriculture and fishing which indicates a 6 per cent decline from the earlier estimates for 1969. The largest upward revision in value is in manufacturing which increases by \$132 million or a further 5 per cent. A large part of the gain is attributed to additions of production facilities in a number of industries such as chemicals, wood products, non-metallic mineral products and textiles. Most of the other manufacturing industries are showing a favourable level of expected expenditures in comparison with 1968 and the earlier estimates for 1969. Utilities and mining account for a large part of the remaining increase in the business sector as a result of upward revisions mainly in communications, water transport and services, railways and in the expenditure programmes of petroleum and gas producers.

The 1969 total for housing and social capital is now showing an increase of 10 per cent over 1968 following a further gain of \$58 million or 2 per cent in housing, and 1 per cent decrease in the revised 1969 estimates for social capital. Spending plans of government departments are now expected to be slightly higher than projected at the beginning of 1969, resulting in an increase of 7.5 per cent over 1968. However, when municipal water systems (included under Utilities in Table 1) are added to government spending, the total increase over 1968 becomes almost 9 per cent. Intended capital expenditures of institutions, on the other hand, are down by 3 per cent from the first estimate for 1969 but increasing by 4 per cent over the 1968 level.

Revised mid-year estimates of 1969 capital expenditures in each province show further increases for most of the provinces with the exception of New Brunswick and Saskatchewan. Regionally, the total for the Atlantic Provinces is unchanged from the earlier estimates for 1969 which was 11 per cent higher than the regional level in 1968. These results reflect the increase in expected 1969 spending of utilities in Newfoundland and Nova Scotia, increases in all the provinces of the region for housing and for the group of industries comprising trade, finance and commercial services. A strengthening in manufacturing in Nova Scotia contributed significantly to the gain for this activity in the regional total. These increases were offset by reductions in plans of the primary industries group and of institutions and governments in the region. Estimates for total capital expenditures in the Atlantic Provinces now show gains over 1968 of 10 per cent in Newfoundland, 12 per cent in Nova Scotia and 15 per cent in New Brunswick. The decrease for Prince Edward Island is now 7 per cent following the 12 per cent year-over-year decline expected at the beginning of 1969.

The capital outlays planned for the province of Quebec are being increased by an additional 2 per cent in 1969 for a total of 5 per cent over the 1968 level. Further increases over the first estimate for 1969 are shown in manufacturing (2 per cent), utilities (4 per cent), housing (2 per cent), trade, finance and commercial services (1 per cent), institutional services and government departments (1 per cent). The group of primary industries shows a decrease of 1 per cent from the earlier estimate for 1969.

Intended capital expenditures in Ontario are estimated at a 1969 level of 1 per cent over the first total for the year and 16 per cent above 1968. A comparison of the mid-year estimates for 1969 with the earlier appraisal shows an increase of 5 per cent in manufacturing and 2 per cent in housing. The total of utilities is unchanged from the earlier estimate. A slight decrease (1 per cent) is expected in the primary industries, as well as in trade, finance and commercial services. Institutional services and government departments show a downward adjustment of 3 per cent.

The revised 1969 estimates for the Prairie Provinces are 3 per cent higher than the earlier estimates for the region and 6 per cent above the 1968 level. Further increases in expenditures are planned for 1969 in utilities (5 per cent), primary industries (2 per cent), manufacturing (13 per cent) and in facilities of trade, finance and commercial services (4 per cent). The amount for institutions and governments is almost unchanged while housing is adjusted upward by a further 2 per cent. Estimates in these provinces now show gains over 1968 of 8 per cent in Manitoba and 14 per cent in Alberta. Saskatchewan is expected to be about 9 per cent below the 1968 level.

In British Columbia, an additional 5 per cent increase is expected to raise the level for the year to 12 per cent over the 1968 total of capital expenditures. All industry groupings reflect this upward adjustment to the first estimates for 1969, particularly institutional services and governments (8 per cent), the activities associated with trade, financial and commercial services (16 per cent) and the manufacturing industries (10 per cent). Small further gains are expected for 1969 in the primary industries group, housing and utilities.
