**SECTION I PRIVATE AND PUBLIC INVESTMENT IN CANADA,
OUTLOOK 1970 - MID-YEAR REVIEW**

A recent survey of capital spending intentions of all sectors of the Canadian economy indicates that capital outlays of \$17,965 million are now planned for 1970. This program slightly exceeds the \$17,835 million that had been planned at the beginning of the year and which was reported in "Private and Public Investment in Canada-Outlook 1970" (Catalogue No. 61-205). Present capital spending plans if fully implemented would involve an 8 per cent increase in such spending over 1969. These figures are in terms of dollar value and if allowances were made for price changes the increase would be somewhat less.

These surveys of investment intentions are conducted by the Dominion Bureau of Statistics and cover business establishments, institutions and all levels of government. The earlier survey was completed in January 1970 and in the recent survey respondents have been asked to report any revisions to their earlier estimates.

The latest information revealed some changes in the components of expected 1970 capital expenditures. Expenditures for the acquisition of new machinery and equipment during 1970 are now estimated at \$6,609 million, about three per cent higher than the earlier 1970 estimate of \$6,425 million and about 11 per cent over the 1969 preliminary total of \$5,940 million. Total construction, however, is expected to be almost one per cent lower than first projected for 1970 for an overall increase of six per cent over 1969. This downward adjustment is attributable to a reduction in the estimated expenditures for housing in 1970 to \$3,030 million from the earlier total of \$3,200 million expected at the beginning of the year. The present housing programme represents a decline of 10 per cent from the \$3,370 million expended in 1969. Non-residential construction, on the other hand shows sustained strength. The new level, at \$8,326 million, is up one per cent from the first estimate for 1970 of \$8,240 million and is 14 per cent higher than the 1969 level of \$7,302 million.

The major upward revision in spending plans since the beginning of the year is in the business sector. Business investment is now expected to total \$11,190 million, about 3 per cent more than had been planned earlier and 14 per cent above the 1969 level.

The most important increases in business investment occur in the mining, manufacturing and utilities groupings. Mining investment is now expected to exceed that of last year by 13 per cent compared with the 6 per cent increase expected earlier. The upward revision is attributable to expanded plans for gas processing plants, coal, asbestos and nickel-copper mines. The further 6 per cent expansion indicated in the manufacturing sector would bring outlays in that area to a level 31 per cent above 1969. An upward revision of \$111 in expansion plans of the paper products industry in Manitoba and other regions has contributed importantly to the gain in manufacturing over earlier expectations for 1970. Changes in other manufacturing sectors were in considerably lesser amounts with increases of the order of \$10 to \$25 million being revealed in food and beverages, printing and publishing, machinery, transportation equipment and petroleum refining. A downward revision of a similar magnitude is made only in the miscellaneous manufacturing category and in primary metals. In the latter case the program planned for 1970 is still substantially above that of the previous year.

A further 4 per cent increase in plans in the utilities sector brings expected spending in that area to 11 per cent above that of last year. The increases here are largely attributable to electric power and telephone companies.

The only significant decline in business investment is in agriculture where capital expenditures are now expected to be 9 per cent below those of last year. While plans in the trade-finance-commercial services area are revised marginally downwards, they still involve an 11 per cent increase over spending in 1969.

Planned capital outlay for social capital purposes are little changed from those formulated at the beginning of the year. It is now estimated that spending by institutions will be a little less than had been expected earlier due to a smaller university construction programme. This decline is partially offset by a slight increase in capital spending by all levels of government. On the basis of present estimates, capital outlays for institutions will increase by 6 per cent over those of 1969 and those by government by 10 per cent.

On a provincial basis the most notable revisions to earlier plans have been in the Atlantic Provinces and in Manitoba where plans have been revised upwards and in Saskatchewan where it is now estimated that expenditures will be less than had been expected earlier. These changes, in part, reflect the up-dating of information on some large projects. For example, the totals for manufacturing in New Brunswick and in Manitoba are revised upward significantly. Similarly, a reassessment of expectations for such areas as agriculture and housing for the year 1970 contributed to lower estimates for certain provinces, especially Saskatchewan. On the basis of the revised estimates in 9 of the 10 provinces, capital expenditures are expected to exceed those of 1969 by the following percentages: Nova Scotia (19%), Prince Edward Island (16%), Newfoundland (15%), Ontario (13%), British Columbia and New Brunswick (7%), Alberta (6%), Quebec (5%), and Manitoba (3%). In Saskatchewan a decline of 9 per cent is now anticipated.

In the Atlantic Region, further increases at mid-year could be attributed in large part to recorded expansions in manufacturing, particularly of paper products and petroleum products. Some further strength is shown in utilities in Newfoundland and Nova Scotia but the lower total for institutions and governments offsets much of the increase. The reverse situation is shown for New Brunswick where a gain in social capital exceeds the decrease for utilities. Present indications are that housing will be higher than the original projection only in Nova Scotia in the Atlantic Region.

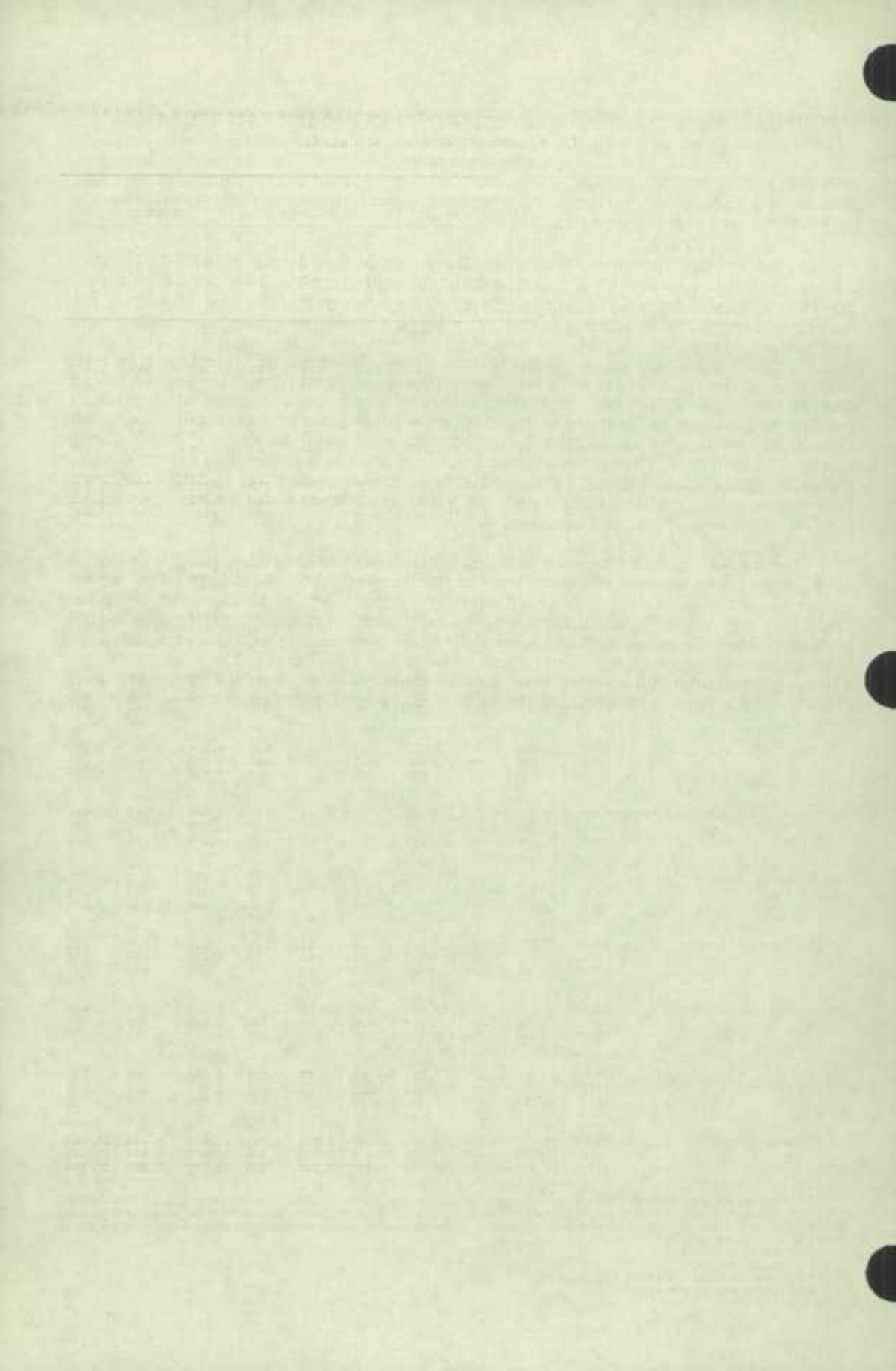
The new mid-year total of 1970 capital expenditures in Quebec, at \$3,404 million, is slightly lower than the \$3,424 million expected earlier this year. The level for manufacturing is increased by \$41 million following increases in the estimates mainly for oil refineries, chemical products, machinery and non-metallic mineral products. In the other sectors, the trade, finance and commercial services group and governments are reported as relatively unchanged compared with programmes previously envisaged for 1970. However, estimates for utilities, housing, and institutions are reduced from the level expected at the beginning of the year following review of more current information.

Intended capital spending in Ontario is now expected to be \$69 million less than was estimated in the first 1970 figures. Most of this decrease is in manufacturing, namely, in chemical products, the miscellaneous group of industries, oil refineries, electrical products and in primary metals. Estimates are also reduced for housing, and for trade, finance and commercial services. Some further expansion is expected by utilities, by governments, and to a lesser extent by institutions.

In the Western Provinces, the most notable change at mid-year is in Manitoba where a more up-to-date assessment of capital expenditures in the province added \$88 million to the 1970 estimates for manufacturing reported at the beginning of the year. There are only moderate changes in the amounts for the other three Western Provinces for manufacturing. The revised lower 1970 estimate for agriculture contributes to the smaller totals shown in the primary industrial group for all four provinces. However, in Alberta, the decrease is largely offset by an increase in the mining programme. In utilities, the earlier level of capital expenditures is further increased generally while the governmental capital expenditures are lower for Manitoba and higher in the other provinces. Institutional spending is indicated as lagging somewhat with the exception of Manitoba where a small further increase is projected. The trade-finance-commercial group is now expected to be moderately higher in Manitoba and Alberta, unchanged in Saskatchewan, and lower in British Columbia in comparison with earlier estimates for the year. The decrease for housing generally is also reflected in the Western Provinces.

The capital spending program outlined in this report is based on the dollar value of such expenditures reported by respondents at the time the survey was made. The accomplishment of the programme may be affected by various factors. Changes in economic conditions may result in modifications to present plans, programmes may be delayed by work stoppages, financing difficulties or other unforeseen problems. Major work stoppages have already occurred in the construction industry in certain areas this year which may adversely affect the full completion of present plans. In fact, in most years since 1957, actual outlays have fallen moderately short of investment plans as stated at mid-year.

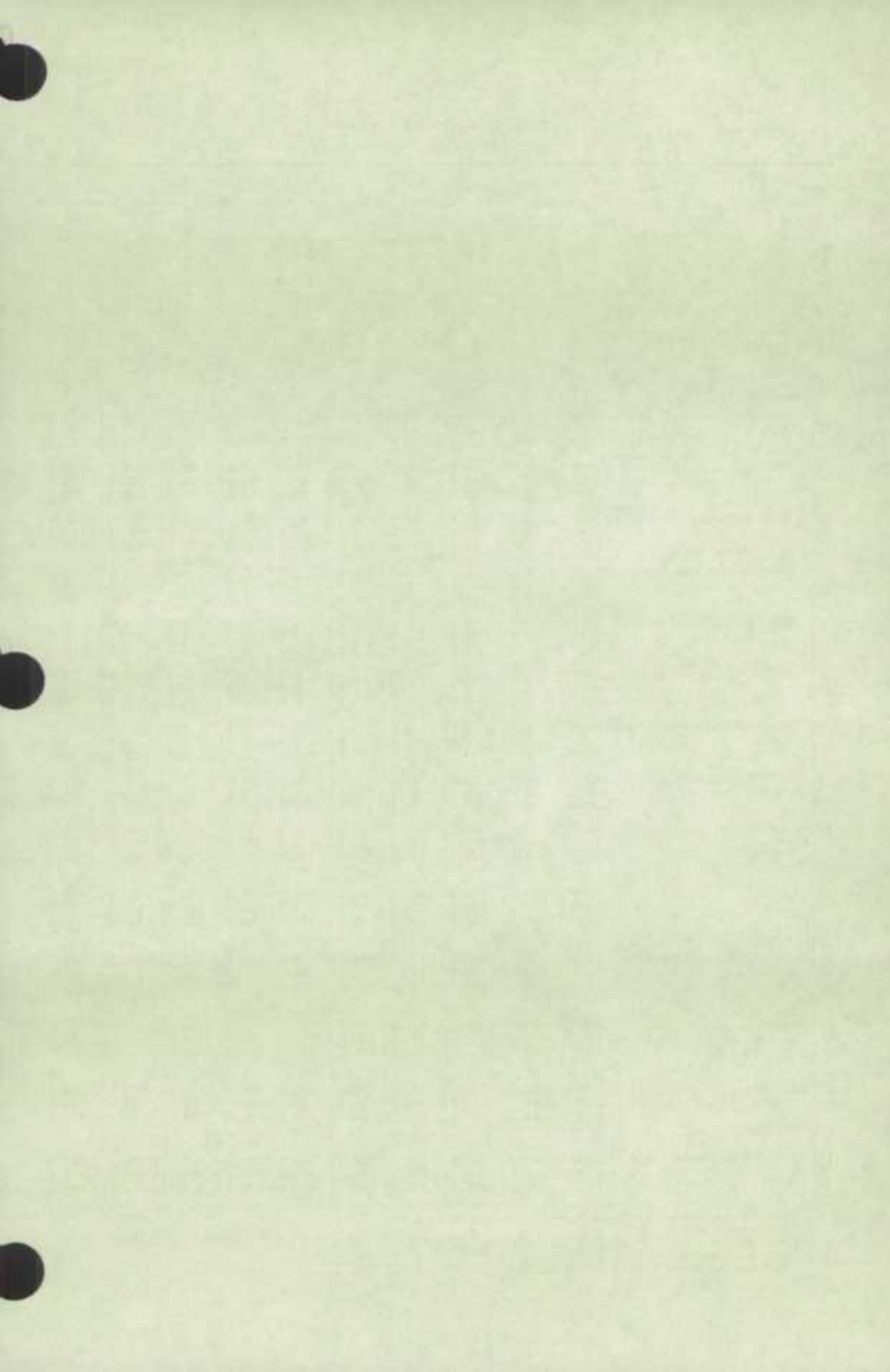

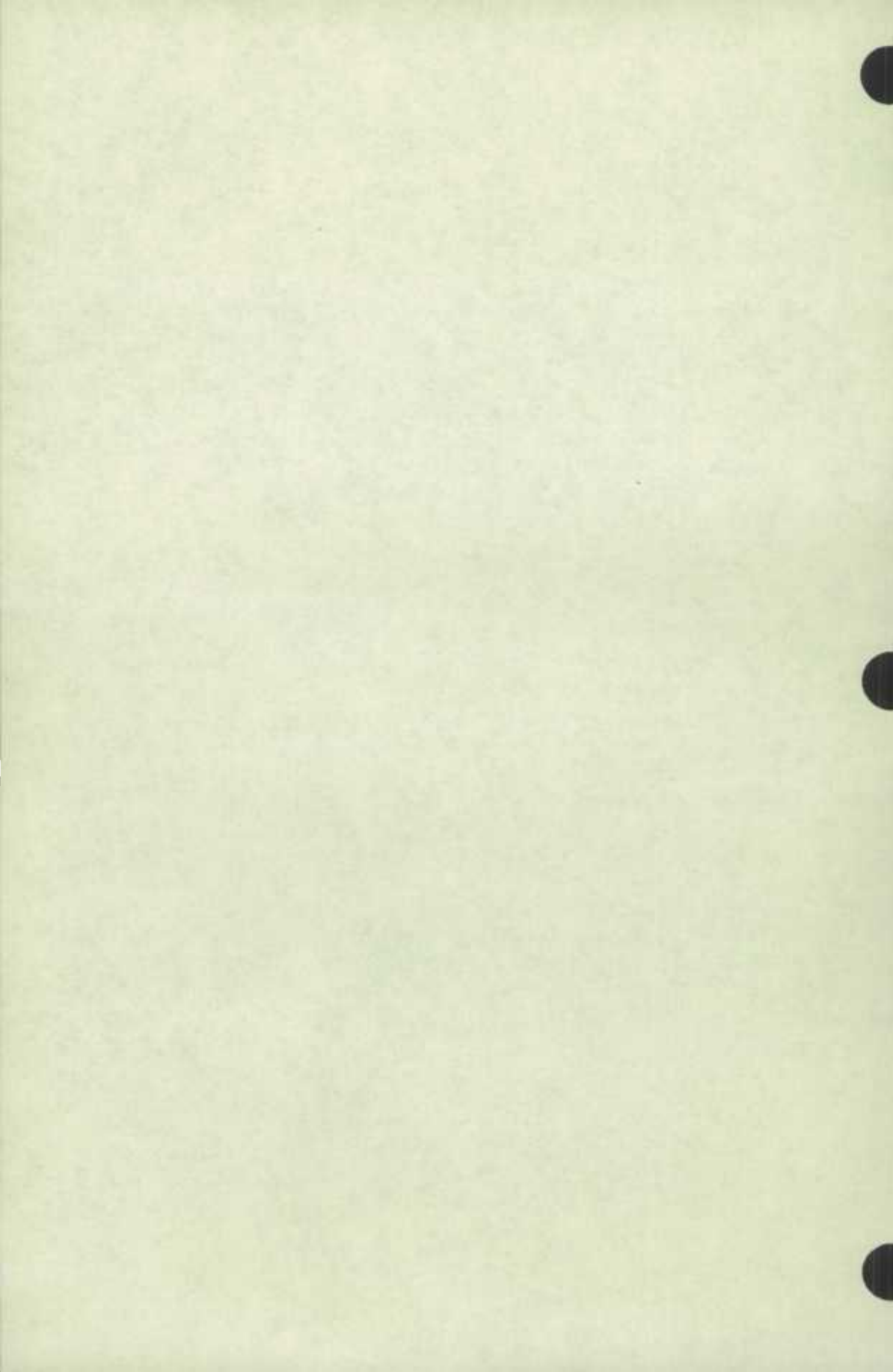
