

## SECTION I. PRIVATE AND PUBLIC INVESTMENT IN CANADA OUTLOOK 1973 - MID-YEAR REVIEW

The total of intended capital expenditures by all sectors of the Canadian economy during 1973 is now estimated at \$24,763 million. This total is 4 per cent higher than the \$23,753 million reported as planned at the beginning of this year in "Private and Public Investment in Canada, Outlook 1973" (Catalogue 61-205). Achievement of these capital spending intentions would involve an increase of 13 per cent over the level of \$21,877 million for 1972. The measurement is in terms of current dollar value and if allowances are made for changes in prices, the increase would be somewhat reduced.

As in previous years, these revised estimates of intended capital outlays at mid-year are derived largely from surveys of investment intentions conducted by Statistics Canada. Business establishments, institutions and governments are canvassed. This year's May-June survey updated earlier estimates of expected spending for 1973 reported in the survey completed in January 1973. The revised estimates of housing expenditures are based on the most recent available information.

The latest results indicate a further increase of 4 per cent in expenditures for buildings and other structures reaching a level 9 per cent above comparable spending in 1972. The total value of new construction is now estimated to be \$15,644 million compared with \$15,092 million in the earlier estimate for this year and the \$14,298 million for 1972. New housing outlays are now expected to amount to \$4,933 million this year, up 4 per cent both from earlier estimates and from the high level of \$4,736 million achieved in 1972. The latest measurement of expected value of 1973 non-residential construction (\$10,711 million) is more than 3 per cent higher than the earlier stated intentions of \$10,352 million and, if achieved, will represent a gain of 12 per cent over last year.

Planned capital spending for the acquisition of machinery and equipment is registering additional strength during 1973 with a new total of \$9,119 million which, if implemented, will be 5 per cent higher than the earlier expectation of \$8,661 million for this year, and 20 per cent over the preliminary actual total of \$7,579 million for 1972.

Revisions to plans of capital outlays for 1973 were more pronounced in the business sector than in spending for social capital. The new total of \$15,340 million for the business group, excluding housing, is now expected to be 5 per cent higher than the \$14,606 million originally estimated earlier this year. The further increase places this year's level at 19 per cent over that of \$12,876 million for 1972. Within these totals, the trade-finance-commercial group of industries is showing the initiation and further expansion of vigorous programs of capital expenditures, where expansions for hotels, office buildings, retail stores and other commercial establishments increased the latest estimate to 9 per cent over the earlier total for 1973 and to 32 per cent over the preliminary actual for 1972.

Expanded plans by the manufacturing industry provide the major stimulus in dollar terms to the overall rise in investment intentions. Manufacturing investment is now expected to exceed that of 1972 by 19 per cent, this represents an increase of 9 per cent over earlier plans for 1973. This added strength is reflected in most industries and especially for oil refineries, food and beverages and for the chemical products industry. Percentage increases at mid-year are high for a number of industries such as rubber products, textiles, furniture and fixtures, non-metallic mineral products. While in the broad utilities group (including transportation, communication and public utilities) there was little change in plans from those expressed earlier, these still involved a 19 per cent increase over the level of spending in 1972. Revisions upward for transportation and communication were offset by some decrease in electric power and gas distribution.

In the remainder of business outlays, the mid-year review shows a further strengthening for agriculture, forestry and for iron and non-metal mining. Investment by iron ore mines has not reached the 1972 total but expansions now reported for 1973 have raised the level of total spending by \$44 million over the earlier estimate. Petroleum and gas extraction shows no change from the earlier 1973 total which, however, incorporates an increase of 14 per cent over the preliminary actual for 1972.

Capital outlays for social purposes as estimated at mid-year are almost unchanged for institutional services but higher for government departments compared with the preceding estimates for 1973. Spending programs for universities and schools have been further curtailed in relation to the first estimates for 1973 for a resultant decrease of 33 per cent and 17 per cent respectively from 1972 totals. In contrast, hospital construction is reported at 4 per cent over the earlier 1973 intentions and 25 per cent higher than 1972. The 1973 total for government departments is 2 per cent higher than estimated at the beginning of 1973 and 12 per cent over 1972.

At mid-year, all provinces and the Territories are showing increases in 1973 over the earlier estimates. As a result, a comparison of the mid-year totals with 1972 levels indicates gains in all cases except for a small decline in Newfoundland.

In the Atlantic region, almost all of the industry groups register higher levels of planned capital spending for 1973, the notable exception being the institutions and government group where a small decline is indicated. The primary industries show a sustained strength regionally for 1973 at mid-year in comparison with earlier estimates and with 1972, but in Newfoundland the intended capital spending remains below the 1972 level. New strength is indicated regionally for manufacturing in relation to the earlier estimate for 1973, which changes a decrease to an increase in comparison with last year. In housing and in the trade-finance-commercial group, further regional advances are indicated over the first estimates for 1973 and over 1972. Utilities are also generally higher regionally even though the 1973 totals for Newfoundland remain slightly below the 1972 estimate.

In Quebec, a re-assessment of spending plans at mid-year have resulted in higher levels for most of the industries for a resultant total of \$5,355 million, 5 per cent over the \$5,115 million representing the earlier 1973 figure, and 15 per cent higher than the \$4,664 million in 1972. In the various industry groups, spending plans of utilities for 1973 were adjusted downward by \$53 million but this amount was more than offset by increases of \$71 million in the primary industries, mainly for mining and for agriculture. Manufacturing also reflects higher planned capital outlays, particularly in the primary metals, and the non-metallic mineral products groups. Percentage gains in other industries showing additional strength were 9 per cent for trade-finance-commercial industries, and 4 per cent for housing, institutions and governments.

In Ontario, the total capital expenditures in 1973 are now estimated at \$9,181 million, 4 per cent over the preceding total of \$8,844 million and 11 per cent higher than the 1972 total of \$8,247 million. The recent revisions in 1973 spending plans show a 7 per cent upward adjustment for manufacturing and for the trade-finance-commercial group. In manufacturing, all industry groups are higher with the exception of a decrease of \$13 million in primary metals. Housing and the primary industries are also indicating that the earlier expected spending in 1973 will be increased, thus also resulting in a gain over the 1972 level for both activities. Institutional services and governments are unchanged from the earlier 1973 figure and moderately higher than 1972. The utilities show a marginal reduction from the first stated intended 1973 spending but attain a level 11 per cent above 1972.

In the Prairie Provinces, most industry groups show a further regional increase over the earlier expected capital outlays in 1973 with the exception of utilities and housing. The housing program for Alberta and Manitoba is lower than was first expected for 1973 and is also lower than in 1972, unlike Saskatchewan where increases are shown over the first estimate for 1973 and over 1972. The trade-finance-commercial group and manufacturing, however, exhibited notable strength at mid-year both regionally and in each province. Institutions and governments and the primary industry group show small increases at mid-year for 1973 to a level well above last year.

Capital outlays during 1973 in British Columbia are now being shown 5 per cent above the earlier expectations for this year. The new total of \$3,193 million is 11 per cent higher than 1972. All industry groups are indicating gains at mid-year, particularly in utilities where facilities for transportation are being expanded further. Manufacturing increased by 2 per cent over the earlier estimate for 1973 but with a more limited program of capital spending in the paper products group, this year's total is still 9 per cent or \$32 million below the 1972 level. Total outlays for the trade-finance-commercial group indicates a sizeable expansion underway at 9 per cent over earlier estimates for 1973 and 24 per cent over 1972. Housing is now expected to exceed the dollar value for 1972 following the marginal decline estimated at the beginning of this year.

Capital expenditures in the Yukon and Northwest Territories continue to increase with the new total expected to attain \$370 million. Spending of the primary industries, institutions and governments comprises the largest contribution to the latest increase in total investment.

The estimates for capital expenditures in this publication represent the current dollar spending plans as reported by respondents at the time of the survey. Actual accomplishments of the program depend upon a variety of conditions external and internal to the organizations formulating these capital spending decisions.


