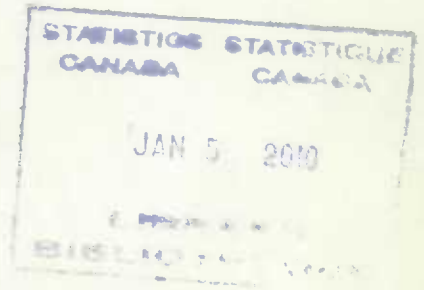

SECTION I. PRIVATE AND PUBLIC INVESTMENT IN CANADA, OUTLOOK 1974 - MID-YEAR REVIEW

Capital expenditures by all sectors of the Canadian economy are now expected to increase to a total of \$31,577 million during 1974. This new estimate is 4 per cent higher than the \$30,318 million of intended capital spending reported earlier this year and published in *Private and Public Investment in Canada, Outlook 1974* (Catalogue 61-205). This program, if achieved, would represent an increase of 21 per cent over the \$26,131 million for 1973. The measurements are in current dollar values without any adjustments for price increases between the two years.

These mid-year revisions of intended capital outlays result largely from surveys of investment intentions conducted by Statistics Canada during May, June and early July covering business establishments, institutions and governments. The results up-date earlier estimates of expected spending for 1974 reported in the survey completed last January. The housing estimate is based upon the current housing construction program and related information.

The latest statistics indicate construction attaining a total of \$20,303 million in 1974. This amount is 4 per cent higher than the \$19,589 million estimated for 1974 at the beginning of this year and 20 per cent higher than the \$16,959 million for 1973. The housing portion of construction activity is now expected to amount to \$6,693 million in 1974, up by 3 per cent from earlier estimates of \$6,504 million, and 13 per cent higher than the \$5,939 million in 1973. The latest estimates of 1974 non-residential construction are expected to increase by an additional 4 per cent to \$13,610 million from \$13,085 million, for an overall gain of 24 per cent over the \$11,020 million of last year.

Plans for the acquisition of new machinery and equipment are showing greater strength than for construction, with an additional 5 per cent registered at mid-year to achieve a new level of \$11,274 million compared with the earlier measurement of \$10,729 million. In relation to 1973 (\$9,172 million), this year's total is expected to be 23 per cent higher.

Revisions to capital spending plans follow the recent patterns of being more pronounced in the business sector than in the combined spending of institutions and governments. Plans of the business group, excluding housing, are now estimated at \$19,537 million, a level of 5 per cent above the earlier total for 1974 and 25 per cent year-over-year. In dollar terms, manufacturing, utilities and the trade-finance-commercial group are registering the most pronounced additions to earlier plans.

The year-over-year increase in manufacturing during 1974 is now expected to be 38 per cent. Knitting mills are the only exception to the general pattern of increases over 1973 with the most notable gains being in chemical products, primary metals, oil refineries, paper products, and in foods and beverages. Inclusion in the total increase of the 7 per cent overall gain at mid-year underscores the basic strength, particularly in the chemical products and wood products groups.

Capital spending in the utilities group during 1974 is showing a new level of 17 per cent over 1973 with telephones and electric power accounting for over \$500 million of the \$850 million total increase. Rail, urban and air transport account for most of the remaining increase, partly offset by a decrease to water transport and services. At mid-year, the only exception to this year-over-year pattern is in water transport and services where some additions to capital budgets narrowed the extent of decrease expected earlier for 1974.

The primary industries indicate large expansion compared with 1973 in agriculture, forestry, mining and in petroleum and gas operations. The latter petroleum and gas group is estimated at 32 per cent above the 1973 expenditures and mining 15 per cent higher during 1974. At mid-year, iron, coal and potash mining contributed significantly to higher levels in the mining group compared with last year.

Capital spending by the trade-finance-commercial sector during 1974 is expected to be substantially higher than in 1973. The finance group of banks, insurance, trust and loan companies and of real estate developers shows a 36 per cent gain, or \$388 million more expenditures this year. Hotels and commercial services show a 26 per cent gain (\$358 million) while the trade group is up by 18 per cent (\$139 million). Mid-year upward revisions contributed to these gains in all the components except in hotels where a decrease of 3 per cent did not change the total significantly. Nevertheless the 1974 planned outlays for hotels remain 31 per cent higher than was expended in 1973.

The strength in business capital expenditures is paralleled somewhat by government departments which are 21 per cent higher this year. Institutions on the other hand increased by only 2 per cent over 1973. This change reflects the reduction for universities offsetting most of the gain for hospitals and other institutions. The mid-year revisions do not materially change this pattern.

At mid-year, re-assessments of earlier capital spending show gains in all the various provinces and territories compared with 1973. These increases in the current capital spending for 1974 compared with 1973 are now as follows: Newfoundland, 9 per cent; Prince Edward Island, 3 per cent; Nova Scotia, 12 per cent; New Brunswick, 50 per cent; Quebec, 22 per cent; Ontario, 19 per cent; Manitoba, 18 per cent; Saskatchewan, 26 per cent; Alberta, 24 per cent; British Columbia, 21 per cent; Yukon and Northwest Territories, 15 per cent.

For the Atlantic region, additions to social capital are estimated at an 8 per cent level above 1973 for housing, and 33 per cent higher for institutions and governments. Large increases are also expected for manufacturing and the trade-finance-commercial group (31 per cent each) and for utilities (22 per cent). Primary industries are up by 9 per cent. The mid-year revisions support this pattern in Nova Scotia except for some stretching out of the spending program for manufacturing. Some changes in the program of governmental spending reduced the extent of the increase in Newfoundland and Prince Edward Island.

Increases in capital spending in Quebec amount to \$382 million in manufacturing (43 per cent) where chemical products, primary metals and oil refineries account for much of the increase although other industry groups also show notable strength in comparison with 1973. The trade-finance-commercial group is also registering a large addition of 45 per cent, followed by utilities with an 11 per cent gain. Increases for social capital are also indicated: 14 per cent for institutions and governments and 18 per cent for housing. While the mid-year re-assessment showed some reductions for utilities and for manufacturing of textiles, the effect was minimal on year-over-year changes.

In Ontario, increases in 1974 over 1973 are shown in all manufacturing industry groups except non-metallic mineral products for a new total increase of over \$600 million or 39 per cent. The largest additions to last year are in chemical products, primary metals, paper products and petroleum refineries. Mid-year modification of the 1974 programs show some cut-backs for paper products, primary metals and petroleum refineries but the remainder still contributed to significant gains over last year. The utilities group now shows an 18 per cent increase over 1973, trade-finance-commercial group is 21 per cent higher and the primary industries group is 22 per cent higher. Spending for social capital is expected to be up by 15 per cent for housing and 8 per cent for institutions and governments. At mid-year a small decrease is shown only for primary industries and for institutions and governments group, thus not changing significantly the overall pattern or year-over-year increases.

The Prairie Provinces are also showing large increases for 1974 compared with 1973 except for housing where a fractional decline is indicated. The primary industries group shows the largest gain at 33 per cent followed by the governments and institutions group at 26 per cent. Utilities and the trade-finance-commercial activities also increased substantially for percentage gains of 22 and 28 per cent. The additional \$89 million of spending by manufacturing in 1974 represents a 22 per cent increase. Mid-year revisions show a small downward adjustment of 2 per cent for the primary industries group but otherwise reflect additional strength in these various industrial groupings.

Substantial increases are registered for all industry groups in British Columbia in 1974. The largest change is in manufacturing where a 45 per cent increase is indicated arising in large part from expansion of the paper products industry. Utilities are also showing a large change amounting to an added \$141 million or 17 per cent over 1973. Primary industries and the trade-finance-commercial activities are higher by 27 and 19 per cent respectively. The strength also shows in social capital where housing increases by \$120 million or 14 per cent and institutional services and government departments add \$103 million to expenditures or 20 per cent. At mid-year, upward revisions re-affirmed this overall expansion although in mining a small 3 per cent decrease moderated slightly from the earlier expected gain for primary industries.

Capital expenditures in the Yukon and Northwest Territories show at mid-year a further 5 per cent for the primary industries group and 10 per cent for the remaining industries (mainly utilities and government). Overall, the added 7 per cent at mid-year for the Territories produces an increase of 15 per cent over last year.

The estimates for capital expenditures in this publication represent the current dollar spending plans as reported by respondents at the time of the survey. Actual accomplishment of the program depends upon a variety of conditions external and internal to the organizations formulating these capital expenditures decisions. Comparisons for the years 1971, 1972 and 1973 show the final total of capital spending exceeding the mid-year level in contrast to a customary shortfall from 1967 to 1970.
