VOLUME OF HIGHWAY TRAFFIC ENTERING CANADA ON TRAVELLERS' VEHICLE PERMITS

MARCH, 1957

A new record was established for the month of March in the number of foreign vehicles entering Canada on travellers' vehicle permits. Entries totalled 85,669 an increase of 9,846 crossings or 13 per cent over the corresponding month of 1956. Cumulative entries for the first quarter were 4 per cent heavier than the same period of 1956 with all provinces showing a gain except British Columbia and entries to Nova Scotia and Newfoundland direct by vessel.

NOTE: Travellers' vehicle permits are issued to foreign vehicles which remain in Canada longer than 48 hours or which travel beyond the jurisdiction of the port of entry. (Thus a motorist who intends to leave the country at a point other than that of entry must apply for a traveller's vehicle permit). Figures shown above refer almost exclusively to automobiles. They include a small number of taxis, motorcycles and bicycles, but exclude buses, trucks and other commercial vehicles. Data for current month are subject to revision. Entries into Canada via Newfoundland and Nova Scotia are by ship.
