VOLUME OF HIGHWAY TRAFFIC ENTERING CANADA
ON TRAVELLER'S VEHICLE PERMITS
MAY, 1955

Foreign vehicles entering Canada on traveller's vehicle permits in May totalled 201,188 an increase of 6,500 vehicles or 3 per cent over the corresponding month of 1954 and a new record for the month. Cumulative entries for the first five months are 4 per cent above last year with all provinces sharing the increase except Saskatchewan, British Columbia and Yukon Territory.

NOTE: Traveller's vehicle permits are issued to foreign vehicles which remain in Canada longer than 48 hours or which travel beyond the jurisdiction of the port of entry. (Thus a motorist who intends to leave the country at a point other than that of entry must apply for a traveller's vehicle permit). Figures shown above refer almost exclusively to automobiles. They include a small number of taxis, motorcycles and bicycles, but exclude buses, trucks and other commercial vehicles. Data for current month are subject to revision. Entries into Canada via Newfoundland and Nova Scotia are by ship.
