## VOLUME OF HIGHWAY TRAFFIC ENTERING CANADA ON TRAVELLERS' VEHICLE PERMITS DECEMBER, 1956.

A new record for the month of December was established in the number of foreign vehicles entering Canada on travellers' vehicle permits. Entries totalled 78,401 an increase of 4,609 vehicles or 6.2 per cent over the previous year and 1.4 per cent over the previous record for the month established in 1953. Data for the calendar year show a decline of 1 6 per cent or some 40,500 fewer entries in 1956 as compared with 1955.

NOTE: Travellers' vehicle permits are issued to foreign vehicles which remain in Canada longer than 48 hours or which travel beyond the jurisdiction of the port of entry. (Thus a motorist who intends to leave the country at a point other than that of entry must apply for a traveller's vehicle permit). Figures shown above refer almost exclusively to automobiles. 'They include a small number of taxis, motorcycles and bicycles, but exclude buses, trucks and other commercial vehicles. Data for current month are subject to revision. Entries into Canada via Newfoundland and Nova Scotia are by ship.
