SALES AND PURCHASES OF SECURITIES BETWEEN CANADA AND OTHER COUNTRIES

April, 1946

Net sales of securities by Canada to other countries declined to \$13.0 million in April as compared with \$20.2 million in March and \$34.9 million in February. Net sales of Dominion bond issues were \$8.1 million. Trading in Canadian and United States Stocks continued heavy with net purchases of Ganadian stocks of \$1.3 million and net sales of United States stocks of \$2.9 million.

Net sales of securities to the United States were \$17.1 million. Sales of Canadian bonds to the United States amounted to \$13.3 million on balance. Sales of Dominion issues were \$7.9 million, municipals \$1.6 million and other corporations \$ 1.4 million. There were also sales of Canadian new issues of \$1.3 million. Net sales of Canadian stocks of \$0.6 million to the United States were more than offset by net repurchases from the United Kingdom of \$2.0 million.

Net repurchases of securities from the United Kingdom were \$4.2 million; \$2.0 million repurchases of Canadian stocks, \$1.7 million repurchases of other corporation bonds and \$0.5 million repurchases of municipal bonds.

The trade with other countries increased slightly in volume and there were net sales of \$0.1 million.

During the first four months of 1946 net sales of securities of all countries amounted to \$85.8 million as compared with \$45.1 million in the corresponding period of 1945. The increase results chiefly from higher net sales of Canadian bonds which were \$74.9 million in 1946 as compared with \$26.6 million in 1945. During this period of 1946 net sales of Canadian stocks were \$4.7 million lower than in the same period of 1945 and net sales of United States securities were \$2.8 million lower than in 1945.

In table 4 showing quotations and yields for domestic government bonds in Canada, the United Kingdom and the United States, the Canadian and United States issues remained relatively stable, while the United Kingdom issue advanced sharply.

In table 5 showing the index numbers of the common stocks prices in Canada and the United States, the Canadian gold stocks dropped slightly while the mining stocks advanced. Both Canadian and United States industrials advanced sharply to new high levels.

The international trade in securities shown by statistics in this bulletin was carried on through the medium of the investment dealers, stock exchanges, banks, Canadian branches of United States houses and other agencies in Canada. It should be noted that certain types of international security transactions are not included in these statistics. Besides some transections carried on directly outside of Canada independently of the reporting agencies the most important group of security transactions not included are new issues of Canadian securities floated abroad, the redemption of called or matured Canadian bonds owned abroad, and official repatriation operations. For a period of years, retirements of Canadian bonds owned outside of Canada have exceeded flotations of new issues abroad by substantial amounts. Statistics of these capital movements are included in the annual reports of the Canadian Balance of International Fayments.


