

This monthly publication provides estimated values of manufacturers' shipments, inventories and orders by month, based on a sample of about 11,500 establishments. Data are presented by major groups and selected individual industries as defined by the 1980 Standard Industrial Classification as well as aggregates for durable, non-durable and total manufacturing Principal series are shown with and without adjustment for seasonal variation. Unadjusted shipment totals by province and by major groups within provinces are also shown. These data are used to monitor the business cycle in the key manufacturing sector of the economy; to evaluate and develop financial and industrial policy; and to provide market data at the detailed industry level.

31-530 DESTINATION OF SHIPMENTS OF MANUFACTURERS

Presents values of shipments of Canadian manufacturing establishments by province of origin and of destination, and gives and "outside Canada" destination. Industry detail includes: all manufacturing, major groups (2 digit S.I.C.) and industry (4 digit S.I.C.) classified according to the 1980 Standard Industrial Classification. The data source is the Census of Manufacturers. The previous edition was 1979 and next edition will be 1989, available about mid 1992.

50-002 SURFACE AND MARINE TRANSPORT- SERVICE BULLETIN

Eight issues per year, this service bulletin presents timely data, time series analysis, and special tabulations covering trucking, rail, bus, urban transit, and marine transportation, and highway infrastructure. Regular topics include the Quarterly For-hire Trucking Survey, the Quarterly Motor Carrier Freight and Household Goods Movers Survey, commodity movements, port activities, vehicle registrations, and fuel sales.

51-002 AIR CARRIER OPERATIONS IN CANADA

This quarterly publication presents operational and financial statistics for the activities of approximately 350 Canadian air carriers. It provides information to be used in the monitoring of the Canadian air transport industry. Specific tabulations presented include data on passenger-kilometers, aircraft hours flown, goods carried, operational expenses and revenues by province and travel by fare type.

51-004 AVIATION - SERVICE BULLETIN

Each month, this bulletin presents the most up-to-date available information gleaned from all of the Aviation Statistics Centre's surveys. Regular features include releases on principal statistics for Canada's major air carriers, airport data, fare basis statistics and traffic data for Canada's most important markets.

51-005 AIR CARRIER TRAFFIC AT CANADIAN AIRPORTS

Released quarterly, this publication presents statistics on airline traffic such as the volume of flights, passengers and cargo, at Canadian airports. Data on Canadian and foreign airlines' regional and local scheduled services have been added to complement the data previously published on the major scheduled services and major charter services. Civil aircraft movement statistics are also shown, thus, providing the overall perspective of aircraft movements at major Canadian airports. The publication presents several summary tables which have been grouped into sections dealing with overall or specialized views of the airline industry. An analysis of the significant changes which have occurred in the survey period is provided, by type of service. Annual summary data are included in the fourth quarter issue.

51-204 AIR PASSENGER ORIGIN AND DESTINATION, DOMESTIC REPORT

This annual publication presents statistics and analysis on the volume of domestic air passenger traffic generated at Canadian cities and carried between pairs of Canadian points. The data may be used to indicate the relative community of interest between Canadian cities.

51-205 AIR PASSENGER ORIGIN AND DESTINATION, CANADA - UNITED STATES REPORT

This annual publication presents an integrated set of Canada/U.S. air passenger origin-destination statistics and analysis, and is the result of an agreement between Canada and the Department of Transportation in the U.S.A. to exchange data from their respective surveys. The data may be used to indicate the relative community of interest between Canada and the United States.

51-206 CANADIAN CIVIL AVIATION

This publication is an annual statistical review of the activities of approximately 260 Canadian air carriers operating in Canada. Finance data include income statements, balance sheets, revenues by province and information on travel by fare type. Operational data include passengers carried, kilometers and hours flown and information on carrier fleets.

51-207 AIR CHARTER STATISTICS

This annual publication contains statistics and analysis on the operations of approximately 100 Canadian and foreign air carriers providing charter services both within Canada and to or from Canada. Data presented in graphical and tabular formats include passengers and cargo volumes along with origins and destinations.

51-501E AVIATION IN CANADA: HISTORICAL AND STATISTICAL PERSPECTIVE ON CIVIL AVIATION

Produced in 1986, this publication describes the Canadian aviation industry from its earliest achievements to the present. It contains data on key markets, airports, air regulation, Canada's air safety record and the growth of recreational flying. The text is complemented by more than 100 charts, tables and photographs. Next issue will be released in 1993.

52-001 RAILWAY CARLOADINGS

This monthly publication presents information on number of cars and tonnes of revenue freight loaded, by Class I and II railways in Canada for 69 commodities. With tables for Eastern and Western Canada supplemented by a chart portraying the daily average freight loaded. This publication is considered a good current indicator of total and regional economic activity.

52-003 RAILWAY OPERATING STATISTICS

Information on seven railways, including operating, financial and traffic statistics, is available in this monthly publication. Data on VIA, Canadian National and Canadian Pacific railway operations are presented separately.

52-216 RAIL IN CANADA

This annual publication provides information relating to the size and structure of the Canadian Railway industry. A general overview of the industry for a six year period is followed by a more in-depth analysis on the economic performance, financial structure and equipment use for the reference period. The publication also provides commodity origin and destination data series supplied by the National Transportation Agency. Each year, one or more special studies on topics related to the railway industry are also presented.

53-003 PASSENGER BUS AND URBAN TRANSIT STATISTICS

This monthly publication outlines passenger revenues, fare passengers carried, vehicle kilometers run and fuel consumed on passenger bus and urban transit systems with gross operating revenues from intercity / urban transit operations exceeding \$1 million.

53-215 PASSENGER BUS AND URBAN TRANSIT STATISTICS

Investment, operating revenues, expenses, and urban transit systems are outlined in this annual publication. Also included are data analysis, methodologies, a glossary and comments on data quality.

53-218 ROAD MOTOR VEHICLES - FUEL SALES

This annual publication presents gross and net sales of gasoline and net fuel sales of diesel oil and liquefied petroleum gas used for automotive purposes are presented by year and by month, by province and territory.

53-219 ROAD MOTOR VEHICLES - REGISTRATIONS

Data on registration of motor vehicles by type including passenger automobiles, trucks, motorcycles, buses, trailers and other vehicles are presented in this annual publication. A historical table of total registrations is provided. Motor vehicle registrations are shown by census divisions and municipalities, where available. Included is a chart showing the interprovincial differences to facilitate analysis of the data.

53-222 TRUCKING IN CANADA

This annual publication presents a comprehensive overview of the Canadian trucking industry, both for-hire and private or own account. Principal information includes statistics on revenues and expenses, equipment operated, investment, employment, and commodities transported from point of origin to point of destination. Also included are data analysies, special studies, a glossary, and a section on methodology and data quality.

54-205 SHIPPING IN CANADA

This annual publication presents a comprehensive overview of international and domestic shipping activity at Canadian ports. It provides vessel traffic data and commodity detail by points of loading and unloading, as well as information on leading ports and containerization. In addition, key indicators on the size and structure of the Canadian water carrier industry are given, plus financial and operating statistics on revenues, expenditures, services provided, employees, property values, fleet composition and fuel consumption.

55-001 OIL PIPELINE TRANSPORT

This monthly publication contains receipts and deliveries by source and by movement of crude oil and refined petroleum products by gathering and trunk lines, by province, cubic-metre kilometers, inventory levels and data analysis.

55-201 OIL PIPELINE TRANSPORT

This annual publication covers the crude oil pipeline and product pipeline transport industry. Cubic metres of oil carried by gathering and trunk lines by province, by month; receipts and deliveries, cubic-metre kilometers, pipeline distance; balance sheet, property account, income and expenses, employment and payroll. Includes data analysis and glossary.

61-205 PRIVATE AND PUBLIC INVESTMENT, INTENTIONS

This annual publication presents capital and repair expenditures on construction and on machinery and equipment for all sectors of the Canadian economy and by province for selected industry groups. The report also provides the split between private and public investment, business and social capital and current and constant dollars. The tabulations focus on capital spending intentions for the coming year, preliminary estimates of actual investment for the current year and the actual investment for the previous year. The investment data are gathered from about 22,000 establishments and establishment groups in Canadian businesses, institutions and governments.

61-206 PRIVATE AND PUBLIC INVESTMENT IN CANADA, REVISED INTENTIONS

This annual publication presents capital and repair expenditures on construction and on machinery and equipment for all sectors of the Canadian economy and by province for selected industry groups. Capital and repair expenditures split between private and public investment, business and social capital and current and constant dollars are also shown. The tabulations cover preliminary estimates of actual investment for the previous year, the original intentions and revised intentions on capital spending for the current year. The investment data are gathered from about 22,000 establishments and establishment groups in Canadian businesses, institutions and governments.

61-214 CAPITAL AND REPAIR EXPENDITURES, MANUFACTURING SUB-INDUSTRIES, INTENTIONS

This annual publication presents capital and repair expenditures for approximately 100 manufacturing sub-industries at the Canada level. Capital and repair expenditures split between construction and machinery and equipment are also shown. All tabulations present the spending intentions for the coming year, preliminary estimates of actual investment for the current year and the actual investment for the previous year. The data are based on a sample of approximately 9,000 individual establishments.

****** NON-CATALOGUE CAPITAL EXPENDITURES ON MACHINERY AND EQUIPMENT, BY TYPE OF ASSET

Estimates of capital expenditures on machinery and equipment by type of asset at the Canada and provincial/territorial level for most sectors of the economy are computed for the actual investment for the previous year.

62-001 THE CONSUMER PRICE INDEX

Monthly release of the Consumer Price Index for Canada and for the 18 regional cities. Provides a descriptive capsule summary of retail price movements and the factors underlying them. Also contains the following tabular information: latest price index movements for the seven major components; price index changes on one and 12-month bases for an extensive number of components and groups; historical monthly information; seasonally adjusted monthly price movements; and price indexes reclassified according to categories of goods and services.

62-004 FARM INPUT PRICE INDEX

This quarterly publication shows indexes of prices of commodities and services used in Canadian farming operations for Eastern and Western Canada, and provides a national total. Farm Input Indexes are now available for the Atlantic Region, Quebec, Ontario, Manitoba, Saskatchewan, Alberta and British Columbia. the publication contains up to five years of quarterly and annual statistics. It also includes technical notes and data analysis.

62-007 CONSTRUCTION PRICE STATISTICS

This quarterly publication contains price indexes of inputs into construction, contractors' selling prices and special purpose aggregations of price indexes for construction and machinery and equipment relating to specified categories of capital expenditures. It also presents new housing price indexes for 20 cities; detailed residential and non-residential building materials input price indexes; and summaries of other construction statistics, as well as periodic articles relating to new or revised construction price statistics. It includes data analysis and technical notes.

62-010 CONSUMER PRICES AND PRICE INDEXES

This quarterly publication highlights the current and historical statistics on consumer prices and related price indexes. A comparative index contains retail price differentials for 11 major cities by selected groups of consumer goods and services. The edition for the last quarter of the calendar year includes a supplement examining price movements in retrospect for the last 12 months. It includes definitions and data analysis.

62-011 INDUSTRY PRICE INDEXES

This monthly publication provides monthly and annual indexes of industry selling prices for manufacturing industries, with commodity detail; purchase price indexes of selected industrial materials, and energy selling price indexes. Charts and graphs, explanation of methods used, and additional sources are included.

62-553 THE CONSUMER PRICE INDEX REFERENCE PAPER: UPDATING BASED ON 1986 EXPENDITURES

This reference document, released in conjunction with the eleventh updating of the Consumer Price Index (CPI), describes all aspects of the CPI, including definition, scope, concepts, data collection, calculation and interpretation of the index. Also includes a number of appendices pertaining to the 1986 weighting diagram and classification system, and a comparison between the 1982 and 1986 weighted indexes.

62-556 INDUSTRIAL PRODUCT PRICE INDEXES, 1981=100 Concepts and methods

This reference document was released in conjunction with the third updating of price indexes for the outputs of Canadian manufacturers and describes the concepts and methods used in the index calculation: formula, source and patterns of weights and sampling procedures are discussed. The measures of data quality provided are described. A detailed description of the commodity classification is given together with an outline of the aggregation systems used both for commodities and industries.

62-558 INDUSTRY PRICE INDEXES, 1986=100, USERS' GUIDE

This publication describes two sets of price indexes, the Industrial Product Price Indexes (IPPI) and the Raw Materials Price Indexes (RMPI), and it covers four topics. The first section describes the different sets of data and how they are organized. The second section provides some help in choosing the most appropriate index for different uses and describes the main characteristics of the statistics. The third section explains how to link together series from different time periods. The final section gives some general information to users. The intention of this text and accompanying tables is to assist users of the statistics in their selection and use of the figures.

63-007 NEW MOTOR VEHICLE SALES

This monthly publication presents monthly and cumulative sales levels of new motor vehicles: number and value of new passenger cars, trucks and buses by country of origin (North America, Japan and other countries). The data are shown for Canada and the provinces. In addition, supplementary tables provide data seasonally adjusted. Data analysis, methodology, definitions, a bibliography and lists of North American motor vehicle manufacturers, and importers and distributors of overseas manufactured motor vehicles are included.

64-201 CONSTRUCTION IN CANADA

This annual publication contains data on the total value of construction put in place. The analysis includes data for construction in both current and constant dollars for new and repair construction and the type of structure by sector and by province. Seventy different types of structures are covered. The publication also devotes a section on labour content and cost of materials. The tabulations focus on capital spending intentions for the coming year, preliminary estimates of actual investment for the current year and the actual investment for the previous year.

65-003 EXPORT BY COUNTRY

This quarterly publication presents Canada's export trade data (values only) by country and commodity according to the Harmonized System (H.S.) at the two-digit level showing the latest quarter together with the cumulative year-to-date totals (distributed by province of origin).

65-004 EXPORT BY COMMODITY

This monthly publication provides detailed export trade data (quantity and value) for the current month and year-to-date by commodity and country according to the Harmonized System (H.S.) at the six-digit level and summarized data by country, section (H.S.) and province of origin.

65-006 IMPORT BY COUNTRY

This quarterly publication presents import trade data (values only) by country and commodity according to the Harmonized System (H.S.) at the two-digit level showing the latest quarter together with the cumulative year-to-date totals (distributed by province of clearance).

65-007 IMPORT BY COMMODITY

This monthly publication presents detailed import trade data (quantity and value) for the current month and year-to-date by commodity and country according to the Harmonized System (H.S.) at the six-digit level and summarized data by country, section (H.S.) and province of clearance.

65-202 EXPORT, MERCHANDISE TRADE

This annual publication provides detailed annual export data for the current year (quantity and value) by commodity and country according to the Harmonized System (H.S.) at the six-digit level. Also included are summarized data by country and principal trading areas for up to ten years; province of origin by country of destination (including U.S. states); the mode of transport for the current year; and summary export groupings by country for five years.

65-203 IMPORT, MERCHANDISE TRADE

This annual publication provides detailed annual import data for the current year, showing values only by commodity and country according to the Harmonized System (H.S.) at the six-digit level. Also included are summarized data by country of origin, country of consignment and principal trading areas for up to ten years; province of clearance by country (including U.S. states); the mode of transport for the current year; and summary import grouping by country of origin for five years.

66-001 INTERNATIONAL TRAVEL, NATIONAL AND PROVINCIAL COUNTS

This quarterly report contains information by month for the past two years on the province of entry basis in the form of tables and graphs with analytical text summarizing the quarter. Mode of transport and the country of residence of visitors are also included. This report includes estimates of the travel account for the balance of payments both seasonally adjusted and not.

66-201 INTERNATIONAL TRAVEL, TRAVEL BETWEEN CANADA AND OTHER COUNTRY

This annual report summarizes annual findings to and from Canada in the form of tables, charts, maps and an analytical review. The publication provides a profile of international travelers by province/country of residence, area of destination, mode of transportation, purpose, length of stay, expenditures, age group and sex.

67-001 CANADA'S BALANCE OF INTERNATIONAL PAYMENTS

The quarterly publication presents Canada's transactions with non-residents on a quarterly basis. These transactions are grouped under two main accounts: the current account for merchandise, services (including transportation), investment income and transfers; the capital account for borrowing and investments abroad. The transactions are distributed among six geographical areas (quarterly and annually) for the current and two previous years with comments on developments in the current quarter. The fourth quarter issue includes: more detailed breakdowns of some several accounts, together with descriptions and definitions.

67-203 CANADA'S INTERNATIONAL TRANSACTIONS IN SERVICES

This annual publication presents international transactions in the major categories: travel, freight and shipping, business services, government and other services. Business services are shown for three years in detail: receipts and payments for sixteen categories, by province, by country of control, by industry and, for each category, whether or not the transaction is with foreign affiliates; the total of business services are published for selected countries and world trading areas. Transportation detail covers passenger fares (part of Travel); ocean shipping, inland freight, intransit and air freight (part of Freight and Shipping) and transport-related business services.

67-508 CANADA'S BALANCE OF INTERNATIONAL PAYMENTS - HISTORICAL STATISTICS, 1926-1990

This compendium shows much of the detail in 67-001 and 67-203. <u>Note</u>: Revised data in the same format for 1988 through 1991 appears in Part II of the First Quarter issue of 67-001. Updates will appear in subsequent First Quarter issues.

CANSIM:

All historical annual and quarterly series shown in the compendium of historical data (67-508) and its updates are available through CANSIM.

71-001 THE LABOUR FORCE

This monthly presents seasonally adjusted and unadjusted estimates of labour force, employment and unemployment, with unemployment and participation rates analyzed by selected geographic, demographic and occupational variables. It includes updates to historical series contained in 71-201, occasional special analyses and a sample questionnaire, definitions, a list of economic regions and a bibliography.

71-001P LABOUR FORCE INFORMATION

This monthly publication provides a series of summary tables on labour force characteristics for Canada, provinces and metropolitan areas as well as a brief commentary highlighting current developments in the Canadian labour force. This publication is preliminary to 71-001.

71-201 HISTORICAL LABOUR FORCE STATISTICS, ACTUAL DATA, SEASONAL FACTORS, SEASONALLY ADJUSTED DATA

This annual publication presents a selection of historical labour force statistics and related seasonal adjustment information. It also contains several hundred time series, derived from the monthly Labour Force Survey. It includes data analysis, definitions, data quality and the survey questionnaires.

71-220 LABOUR FORCE ANNUAL AVERAGES

This annual publication provides the users of Labour Force Survey data with a convenient source for annual averages estimates. The first section presents an overview of trends in the labour force on specific topics. The second section contains annual averages of all 37 tables contained in the monthly The Labour Force (Catalogue 71-001). It also presents annual averages estimates of some provincial breakdowns not published in the monthly publication as well as more detailed sub-provincial estimates.

71-529 LABOUR FORCE ANNUAL AVERAGES, 1981-1988

This publication provides annual averages for the years 1981 to 1988 of the tables contained in the monthly 71-001, revised to the latest census of population benchmark (1986).

71-536 ENTERPRISING CANADIANS : THE SELF EMPLOYED IN CANADA

This publication offers a comprehensive view of self-employment in Canada. Drawing on data from the Labour Force Survey and the Survey of Consumer Finances, the study provides a wealth of demographic and labour market facts on the self-employed. The report also highlights the dynamic role played by the self-employed in recent labour market developments.

72-002 EMPLOYMENT, EARNINGS AND HOURS, PRELIMINARY DATA

This publication presents a timely picture of employment, earnings and hours which is vital for Canada's businesses and governments for planning and decision-making purposes. The tabulations focus on monthly labour market information and historical data series. The major economic variables for over 280 industries are provided at the national and provincial/territorial level. The publication also includes a succinct monthly highlights section, quarterly feature articles and notes on the concepts and methodology of the survey.

82-602 HIGHLIGHTS: DISABLED PERSONS IN CANADA

This publication profiles Canada's population with disabilities residing in households. The profile includes selected demographic data as well as information on the nature and severity of disability, lifestyle, out-of-pocket expenses, income, and the barriers encountered in everyday activities. Data are presented for various age groups, at the Canada, province and territory levels.

82-603 TO 82-614 SUBPROVINCIAL/SUBTERRITORIAL DATA

These publications, consisting of one publication for each province and territory in Canada, present a statistical profile of the population with disabilities residing in households. Included in this profile are selected demographic data from the 1986 Census of Canada as well as information on the nature and severity of the disability, the barriers encountered in education, employment, accommodation, transportation and leisure activities, the type of technical aids used or needed income and any out-of-pocket expenses incurred as a result of a health condition.

The series features data for the ten provinces and two territories with approximately 200 subprovincial, subterritorial areas, from the Health and Activity Limitation Survey, a comprehensive survey of persons with disabilities conducted in 1986 and 1987.

87-504 DOMESTIC TRAVEL, CANADIANS TRAVELING IN CANADA

This biennial publication presents data, an analytical text on trips and socio-economic characteristics of Canadians traveling within Canada. Trip information includes purpose, activities, mode of transportation, length of stay, duration, origin and destination (O. & D.), expenditures, including some provincial and metropolitan detail.

93-157 CANADIANS AND THEIR OCCUPATIONS, A PROFILE

In a single table, this publication profiles 200 occupations by demographic, socio-cultural and economic characteristics. Occupations appear alphabetically in a list preceding the actual table to help users gain quick access to data relating to a specific occupation. All data are reported from the 1986 Census for both males and females, for Canada only.

93-323 PLACE OF WORK: 2B NATION SERIES : 2B AREA PROFILE SERIES

These publications presents data on the place of work-place of residence links for Canada's employed labour force living in census metropolitan areas. The focus is on matrices showing commuting flows between census subdivisions.

Employed Labour Force 15 years and over by Place of Residence and Sex, Showing Place of Work for Census Subdivisions within the Census Metropolitan Areas.

93-338 CENSUS METROPOLITAN AREA AND CENSUS AGGLOMERATIONS

B9102 CENSUS DIVISIONS AND CENSUS SUBDIVISIONS

This publication presents data on a wide range of census variables shown in the Census Division, Census Subdivision, Census Metropolitan Area and Census Agglomeration series.

PLACE OF WORK BASIC SUMMARY TABULATIONS

Q9101 Employed Labour Force 15 Years and Over by Place of Residence and Sex (3), Showing Place of Work (for Each

Census Subdivision (CSD) of Residence by Each CSD of Work in Each Province, and in Neighboring Province for CSDs in Cross-provincial Census Metropolitan Areas and Census Agglomerations).

Q9102 Employed Labour Force 15 Years and Over by Occupation Major Groups (Based on the 1980 Classification) (23), Age Groups (7) and Sex (3), Showing Place of Work ((for Each Census Subdivision (CSD) of Residence (CSD 5,000+) by Each (CSD) of Work).

Q9103 Employed Labour Force 15 Years and Over by Industry Divisions (Based on the 1980 Classification) (19), Age Groups (7) and Sex (3), Showing Place of Work (for Each Census Subdivision (CSD) or Residence (CSD 5.000+) by by Each CSD of Work).

98-124 CANADA'S YOUTH

This study presents a profile on "young Canadians" between the ages of 15 to 24, as defined by the 1986 Census. Data from both the 1981 and 1986 Censuses are often shown together in this study and focus on Canada's youth in terms of demographic structure, living arrangements, education, work activity and income. In addition, wherever possible, data are presented for two subgroups and for the entire youth population for Canada, the provinces and the territories. The subgroups consist of "teens", aged 15 to 19 and "young adults" aged 20 to 24. They are categorized in this way in order to portray a more accurate picture of one of Canada's most valuable resources for our children.

98-125 WOMEN IN THE LABOUR FORCE

This publication provides a descriptive analysis of women's labour force participation for women who are employed, unemployed and for women who have never been in the labour force. Women are explored in terms of industry, occupation, age, average employment income, marital status, presence of children and education. A number of tables contained in this study also provide comparative analysis between women and men across any of the same variables. In this study, Census data from 1986, data from earlier censuses between 1971 and 1986, and data from related surveys are presented mainly for Canada with only a brief examination of regional variations.

98-129 EMPLOYMENT INCOME

This study presents 1985 employment income for Canada as reported during the 1986 Census. Tabulations for the provinces and territories are briefly presented and only one table features comparisons of employment income for 1970, 1980 and 1985. All data are collected for persons 15 years of age and over and are presented in terms of age, sex, marital status, education, hours and weeks worked, and occupation. The gap between male and female employment earning is also examined in this informative study.

98-135 TRENDS IN OCCUPATION AND INDUSTRY

This study presents readers with 1986 Census data on current patterns of employment by industry and occupation, as well as by age and sex. In addition, data from the 1971 and 1981 Censuses are presented in order to review changes in those patterns and gain insight into how different variables influence particular trends. Data contained in this study are reported mainly for Canada, with statistics for three census metropolitan areas (CMAs) covered only to a limited extent.




