Framework submission - community's itemization of the authorities desired beyond the <u>Indian Act</u>, proposed modifications to its governing structures and the new legislative arrangements sought to enable these changes; workplan and budget for substantive negotiations and the ratification process for any agreements.

Framework documentation - i

information, provided by the community, clarifying and elaborating the framework submission.

Discussion paper - federal government's response to the community's framework submission and documentation.

Framework documentation - information, provided by the community, clarifying and elaborating the framework submission.

Substantive negotiations - negotiations leading directly to new arrangements which will be effected through legislation.

Workshop -

meeting held by a community or communities to inform its members of and/or to discuss self-government issues.
