FPCC staff update

With the recent appointment of Mr. Mike Pickard as interim Chairman and Deputy Head, the FPCC wishes to provide staff update.

As of Friday, June 2, 2017, H       Devost temporarily assumed the responsibilities of the Director of Regulatory, Policy and Sectoral Operations; Nancy Fournier is now the Council Secretary; and Marc Chamaillard will continue to serve as Director Corporate Management and Government Affairs. Nathalie Vanasse will now be assigned to various special projects of importance for the FPCC.

FPCC June 5, 2017 meeting

The FPCC met via teleconference on June 5, 2017, where Council members considered amendments to the *Canadian Chicken Marketing Quota Regulations* for periods A-145 and period A-146, which run from October 6 to November 25, 2017.

Council approved the total allocation of 257,426,910 kg live weight for A-145 and 255,710,292 kg live weight for A-146.
