GLOSSARY

Action plan: SSHRC's Results-Based Action Plan for Implementation of Section 41 of the *Official Languages Act*:

- demonstrates SSHRC's commitment to fulfill its role and responsibilities under section 41 of the Official Languages Act (OLA);
- establishes a link between the priorities of official-language minority communities (OLMCs) and SSHRC's mandate; and
- documents in a structured way the actions and activities SSHRC plans to undertake to contribute to the development of OLMCs and the promotion of official languages.

Activities: Actions or work undertaken to produce outputs; what we do to reach results, with a direct link to results.

Official Languages Act: Section 41 of the OLA commits federal institutions to taking positive measures to:

- enhance the vitality of the English and French linguistic minority communities in Canada and support and assist their development; and
- foster the full recognition and use of both English and French in Canadian society.

Federal institutions subject to the Accountability Framework for the Implementation of Sections 41 and 42 of the *Official Languages Act* (commonly called "designated institutions") are required to submit an annual or multiyear action plan, as well as an annual report on results, to Canadian Heritage.

Official-language minority communities: OLMCs are French-speaking communities living in a territory or province other than Quebec, and English-speaking communities living in Quebec. These are the "English and French linguistic minority communities in Canada" referred to in section 41 of the OLA.

Outputs: Direct products or services resulting from the activities, policies, programs or initiatives of an organization.

Indicators: Elements of meaningful information used to measure progress towards achieving expected results. Indicators can be quantitative (resulting from data collection) or qualitative (resulting from the observation of a phenomenon).

Results/progress: Changes or effects directly attributable to the activities, policies, programs or initiatives of an organization.

Stakeholders: In addition to Canadian Heritage, various stakeholders have an interest in SSHRC's activities related to section 41; these include, in particular, the Senate and House of Commons standing committees on official languages, the Office of the Commissioner of Official Languages, OLMC organizations, and organizations working in the area of university-based research in the social sciences and humanities.

Summary of Progress Expected During the Period Covered by the Action Plan

SSHRC is the federal agency that promotes and supports university-based research and training in the humanities and social sciences. Through its programs and policies, SSHRC enables the highest levels of research excellence in Canada, and facilitates knowledge-sharing and collaboration across research disciplines, universities, and all sectors of society. Created by an act of Parliament in 1977, SSHRC is governed by a council that reports to Parliament through the minister of industry.

SSHRC implements its mandate by awarding research funding on the basis of open, transparent, national competitions and a rigorous peer-review process that assesses the academic excellence and scientific merit of applications for funding. An international blue ribbon panel of experts recently carried out an independent assessment of SSHRC's peer-review system and found that it is "up to the best practices and highest international standards."

In accordance with its mandate and its strict peer-review selection criteria, SSHRC programs are accessible to all humanities and social sciences researchers affiliated with eligible institutions; its programs cannot have quotas based on the applicant's language or type of community and cannot be restricted to certain geographic regions. Peer-review committee members are selected in a manner that ensures equitable representation of expertise, official languages, gender, regions, and institution size.

In meeting its commitments under section 41 of the OLA, SSHRC plans to undertake a wide range of activities in the following areas for the years 2009-12: awareness, consultations, communications, co-ordination and liaison, funding and program delivery, and accountability.

Awareness

SSHRC will develop and put into action a policy statement on its implementation of section 41 of the OLA. It will significantly increase the amount and quality of information provided to its staff, senior management and governing council on SSHRC's responsibilities as a designated agency regarding section 41 of the OLA, and of the value and importance of taking into account the realities of official-language minority communities (OLMCs) in SSHRC activities and decisions.

Consultations

SSHRC will consult with the senior administrators newly appointed as SSHRC Leaders at OLMC universities on how SSHRC may best address the concerns, priorities and needs of OLMC researchers in accessing SSHRC's available funding programs and promoting linguistic duality in Canada. SSHRC will continue to participate in forums and events that provide opportunities to share information and ideas with researchers from OLMC institutions.

Communications

Communications activities provide OLMC researchers with up-to-date and relevant information on available programs, enabling them to take part more effectively in SSHRC programs. Information on SSHRC activities regarding implementation of section 41 of the OLA will be created and updated regularly on SSHRC's website. SSHRC will also disseminate information through various channels on research projects related to official languages in Canada and undertaken by OLMC researchers.

Co-ordination and Liaison

SSHRC will continue to participate on various committees related to official languages research and the implementation of section 41 of the OLA. SSHRC will also assess opportunities to harmonize activities related to section 41 with its partner agencies, the Natural Sciences and Engineering Research Council (NSERC) and the Canadian Institutes of Health Research (CIHR).

Funding and Program Delivery

SSHRC will undertake a management review of its 2004-07 Official Languages Research program (a joint initiative with Canadian Heritage). It will also assess SSHRC's mechanisms for capturing statistics and reporting on research funded on official languages issues and by OLMC researchers, and ensure these are as robust as possible. In addition, it will undertake visits to OLMC universities on a rotating basis to ensure researchers at these institutions are well informed of available opportunities for SSHRC funding and of application processes. Finally, it will provide information to its peer-review committees on SSHRC's responsibilities under section 41 of the OLA.

Accountability

SSHRC's day-to-day operations contribute, within the limits of its mandate, to the following objectives: providing access to funding for researchers in OLMC institutions, and funding research related to official languages and bilingualism that can promote linguistic duality in Canadian society. In accordance with the reporting requirements, SSHRC will submit a detailed annual review of its activities to Canadian Heritage and share this review with other stakeholders.
