

Tourism statistical digest

2001 edition

The 2001 edition of the *Tourism statistical digest* assembles under one cover all the survey results relevant to tourism and travel by Canadians and foreign visitors to Canada. Its many tables and charts illustrate world tourism trends, demand and supply of tourism services in Canada, and the impact of tourism in the Canadian economy in 1999. Each chapter is introduced by a lead article. Data from sources other than Statistics Canada, notably the World Tourism Organization, are also provided.

This publication is intended for all stakeholders in the tourism industry, and will be especially useful to analysts, researchers, managers, teachers and students. It is the result of the work of many authors—most of them from Statistics Canada, but some from the academic community, municipal tourism and convention bureaux and the Canadian Tourism Commission, which also provided half of the funding.

Steel primary forms

Week ending October 6, 2001 (preliminary)

Steel primary forms production for the week ending October 6 totalled 286 365 metric tonnes, up 0.2% from 285 750 tonnes a week earlier but down 8.4% from 312 623 in the same week of 2000. The year-to-date total at the end of the reference week was 11 544 414 tonnes, down 11.2% from 12 993 847 in the same period of 2000.

Dairy statistics

August 2001 and September 2001 (preliminary)

Dairy farmers sold more than 630,000 kilolitres of milk and cream to dairies in August, up almost 2% from August 2000.

Pipeline transportation of crude oil and refined petroleum products

June 2001

Net receipts of crude oil and equivalent hydrocarbons totalled 13 172 142 cubic metres in June, down 1.5% from June 2000. Year-to-date receipts to the end of June were 81 986 275 cubic metres, up 4.9% from the same period in 2000. Net receipts of liquefied petroleum gases and refined petroleum products totalled 6 368 892 cubic metres in June, down 3.0% from June 2000. Year-to-date receipts were 38 246 424 cubic metres, down 5.9% from the same period in 2000.

Pipeline exports of crude oil totalled 6 724 778 cubic metres in June, an increase of 6.7% from June 2000, and pipeline imports were 2 095 419 cubic

metres, a decrease of 8.1%. Year-to-date exports totalled 38 432 106 cubic metres, up 5.9% from 2000. Year-to-date imports were 13 835 561 cubic metres, up 11.2%.

June deliveries of crude oil by pipeline to Canadian refineries totalled 5 516 261 cubic metres, down 6.1% from 2000. June deliveries of liquefied petroleum gases and refined petroleum products were 424 320 cubic metres, down 15.7% from June 2000. Year-to-date deliveries of crude oil to refineries to the end of June totalled 34 364 419 cubic metres, down 0.6% from the same period in 2000.

The number of take-offs and landings at the 98 Canadian airports with Nav Canada air traffic control towers and flight service stations totalled 521,270 in March, down 4.4% from March 2000.

1996 and 1997

The cross-sectional public-use microdata files for the 1996 and 1997 Survey of Labour and Income Dynamics (SLID) are now available.

Up to 1997, the Survey of Consumer Finances (SCF) provided public-use microdata files to meet the needs of users of cross-sectional household income. With the release of these files, Statistics Canada is continuing the transition from SCF to SLID as the source of detailed cross-sectional household income data.


