## MAJOR RELEASES

## Wholesale trade

June 2001 (preliminary)
Mainly as a result of strong sales in the automotive sector, wholesalers saw their sales rise a modest 0.2\% in June. That followed a $2.0 \%$ increase in May. If not for the sales reported by wholesalers of motor vehicles, parts and accessories, June sales would have fallen $0.5 \%$. Declines were reported in 5 of 11 wholesale sectors - 5 sectors that account for approximately 51\% of total wholesale activity.


Nevertheless, as a result of the two consecutive monthly increases, wholesalers on balance also saw a second consecutive quarterly rise in sales, up 1.5\% over the previous quarter. In general, wholesale sales have been rising in 2001 after levelling out during the latter half of last year. Prior to that, wholesale sales had been climbing since mid-1998.

Wholesale sales rose to $\$ 32.9$ billion in June. Apart from the strong wholesale sales in the automotive sector ( $+3.7 \%$ ), notable increases were also reported in the wholesaling of farm machinery and equipment $(+4.2 \%)$, of beverage, drug and tobacco products (+2.0\%), and of apparel and dry goods (+2.0\%).

A notable decline was again observed in the wholesaling of computers and other electronic products, down $3.8 \%$. As well, there was a notable $2.4 \%$ drop in the wholesaling of industrial machinery and equipment.

## Automotive wholesalers the source of strength

As a result of strong imports and exports, wholesale sales of automotive products rose $3.7 \%$ in June. Despite a relatively volatile beginning to the year, wholesalers in this sector have gained some stability to report their second consecutive month of strong sales. The last time that this sector reported back-to-back monthly increases was at the start of 2000, just prior to the slowdown that resulted in generally falling sales by the spring of that year. Sales in this sector have been generally rising since the start of 2001. Among all wholesalers, this sector reported the highest growth in the second quarter, up 6.7\%.

## Woes continue for computer and other electronics wholesalers

Lack of sales was once again evident in June for the wholesaling of computers and other electronics, down $3.8 \%$. This was the fifth consecutive monthly decline for this sector. As a result, wholesale sales have fallen sharply since the start of 2001 despite having generally risen during 2000. Wholesale sales in this sector have eroded to September 1998 levels.


## Increases limited to three provinces

Among the provinces, sales increases were limited to three; Alberta ( $+1.7 \%$ ), Ontario ( $+0.8 \%$ ), and Newfoundland ( $+0.4 \%$ ). All other provinces reported sales declines.

Sectors of strength varied by province. Not surprisingly, Ontario benefited from the strong wholesale sales in the automotive sector. Wholesalers in Alberta and Newfoundland reported healthier sales in the industrial machinery sector and in the hardware, plumbing and heating sector; despite the fact that these areas reported weaker sales nationally.

## Seven months of relative stability in wholesale inventories

Wholesale inventories remained relatively unchanged at $\$ 44.0$ billion for a seventh consecutive month ( $-0.1 \%$ ). Inventory levels have been at a plateau during all of 2001. Prior to this, inventories were climbing over the past several years.

The June inventory-to-sales ratio remained unchanged from May at 1.34 . This is somewhat below the levels recorded earlier in the year.

## Stocks of frozen poultry meat

August 1, 2001 (preliminary)
The amount of frozen poultry meat in cold storage on August 1, 2001 stood at 79.6 thousand tonnes, up 14.9\% from a year earlier.

## Pulpwood and wood residue statistics June 2001

Pulpwood receipts in June totalled 1881089 cubic metres, down 9.5\% from 2077507 cubic metres in June 2000. Wood residue receipts fell $3.4 \%$, from 7463376 cubic metres in June 2000 to 7212495 cubic metres in June 2001. Consumption of pulpwood and wood residue totalled $8 \quad 843732$ cubic metres, down $4.7 \%$ from 9276135 cubic metres in June 2000.

In June, the closing inventory of pulpwood and wood residue increased $4.2 \%$ to 14165142 cubic metres, up from 13595622 cubic metres in June 2000. For January to June 2001, year-to-date consumption of pulpwood and wood residue (58 275017 cubic metres) decreased 1.1\% from 58915340 cubic metres a year earlier.

## Industrial chemicals and synthetic resins June 2001

In June, chemical firms produced 210552 metric tonnes of polyethylene synthetic resins, a $3.2 \%$ decrease from 217470 tonnes in June 2000.

Year-to-date production at the end of this June totalled 1300290 tonnes (revised), down $2.9 \%$ from 1339116 tonnes produced a year earlier.

Data are also available on the production of 3 other types of synthetic resins and 24 industrial chemicals.
