### Census of population: Collective dwellings 2001

Data from the 2001 Census of Population on individuals living in collective dwellings as of May 15, 2001, are now available.

These dwellings include health care and related institutions, corrections and penal institutions, shelters and so on.

This information is available in the document *2001 Census: Collective dwellings*, no. 4 (96F0030XIE2001004, free), which is now available on Statistics Canada's website ([www.statcan.ca](http://www.statcan.ca)). From the home page, choose *Census*, then *Analysis series*. This document contains an explanatory note on data quality for these dwellings, as well as tables on collective dwellings in printable PDF format. Data include the population enumerated in shelters.

### Department store sales and stocks September 2002

Consumers continued to cut back on their spending in department stores in September, causing sales to fall 3.2% from August. The drop brought department store sales to \$1.70 billion for the month (seasonally adjusted), the lowest level recorded in 2002.

Department store sales peaked at \$1.78 billion in January 2002. Since then, department store sales have fluctuated from \$1.70 to \$1.78 billion. Before January, sales had been moving upward since the spring of 2000.

Despite recent declines, department store sales in the third quarter were up 5.6% from the third quarter of 2001. Compared with the second quarter, however, department store sales were down a slight 1.1%. This was the first quarter-to-quarter decline since the fourth quarter of 1999.

At the national level, department store sales, unadjusted for seasonality, advanced 3.2% in September from September 2001, when sales were weak because of the events of September 11. In the same one-year period, sales increased in all provinces, except for slight declines in Ontario (-0.4%) and New Brunswick (-0.6%). Nova Scotia, Alberta, the group formed by Newfoundland and Labrador and Prince Edward Island, and Quebec registered the strongest gains, ranging from 7% to 11%. The remaining provinces had year-over-year sales increases of less than 5.0%.

## Cement

September 2002

Manufacturers shipped 1 427 194 metric tonnes of cement in September, down 2.5% from 1 463 474 tonnes (revised) in August but up 4.8% from 1 362 416 tonnes in September 2001.

Year-to-date shipments at the end of September totalled 9 775 694 tonnes (revised), up 2.1% from 9 577 950 tonnes (revised) in the same period of 2001.

2000–2001

The Canadian Centre for Justice Statistics releases today a product entitled *Graphical overview of the criminal justice indicators, 2000–2001*.

This reference tool contains 99 graphics illustrating current and historical data from a number of Statistics Canada surveys. The graphics show data on police-reported crime statistics, adult provincial and territorial criminal court activity, and youth court activity. The graphics also present data on the adult correctional population, police administration, and environmental factors that may influence crime and the justice system. Some focus issues are represented, such as family violence, justice sector employment, and criminal victimization. Each graphic is accompanied by a short explanatory text.

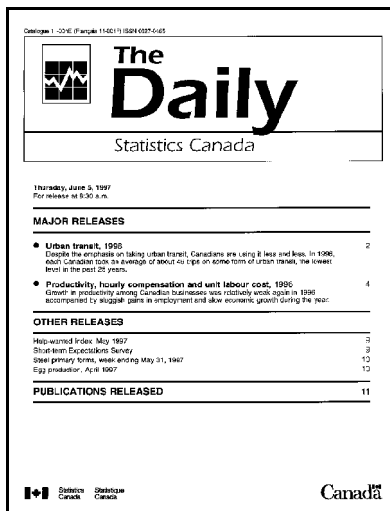
