Low-income cutoffs for 2002

Low-income cutoffs (LICOs) for 2002, before and after taxes, are now available.

LICOs are income thresholds, determined by analysing family expenditure data, below which families will likely devote a larger share of income to the necessities of food, shelter and clothing than the average family would. To reflect differences in the costs of necessities among different community and family sizes, LICOs are defined for five community-size and seven family-size categories. LICOs are updated each year using the annual Consumer Price Index.

Although LICOs are often referred to as poverty lines, they have no official status as such, and Statistics Canada does not recommend their use for this purpose.

Farm product prices

December 2002

Prices received by farmers in December for grains, oilseeds, specialty crops, fruits, vegetables, cattle, hogs, poultry, eggs and dairy products are now available.

The Ontario hog price in December was \$1.30 per kilogram; this was the highest it has been since August, when it hit \$1.56 per kilogram, but still 8% below the December 2001 level.

The December non-board wheat price in Manitoba, at \$157.01 per metric tonne, increased 7% from November. This was the highest it has been since January 1997, when it hit \$163.44 per tonne.


