Monthly Railway Carloadings

February 2004

In February, Canadian railways loaded a total 20.8 million metric tonnes, up 338 000 tonnes, or 1.7% from January 2004.

The non-intermodal freight totalled 240,000 carloads and 18.8 million tonnes, a 2.2% rise from January 2004. Coal loadings had the largest impact with a gain of almost half a million tonnes.

The intermodal portion, that is containers and trailers hauled on flat cars, totalled 2.0 million tonnes in February, a 2.8% drop from January. February's intermodal loadings make up 8.6% of the total tonnage.

Freight coming from the United States either destined for or passing through Canada also dropped slightly in February, reaching 2.6 million tonnes, a 0.4% decline over January.

On a year-over-year basis, February 2004 figures show an 8.9% increase of non-intermodal tonnage from February last year, as well as a 5.3% increase for intermodal traffic and a 5.7% increase for traffic received from the United States.

For the first two months of 2004, the cumulative total for non-intermodal loadings went up 5.2%, from 35.3 million tonnes in 2003 to 37.2 million tonnes in 2004. Intermodal loadings and traffic received from the US showed a similar trend with a 4.0% increase for intermodal loadings and a 5.0% increase for US traffic destined for Canada.

Steel primary forms, weekly data

Week ending April 17, 2004 (preliminary)

Steel primary forms production for the week ending April 17 totalled 324 278 metric tonnes, up 8.2% from 299 680 tonnes a week earlier and 4.1% from 311 582 tonnes in the same week of 2003.

The year-to-date total as of April 17 was 4 750 571 tonnes, up 1.5% from 4 679 646 tonnes in the same period of 2003.

Natural gas sales

February 2004 (preliminary)

Natural gas sales totalled 8 257 million cubic metres in February, down 2.0% from February 2003. Warmer-than-normal weather conditions across the country contributed to the weaker sales. The residential sector showed a drop of 2.5%, while the commercial sector had a larger decline of 5.5%. The industrial sector (including direct sales) showed a slight increase in sales of 0.2%.

Year-to-date sales at the end of February were up 2.0% from the same period of 2003. Both the residential (+4.5%) and the industrial (including direct sales) sectors (+2.3%) posted gains. Use of natural gas by the commercial sector has edged down 1.9% so far this year.

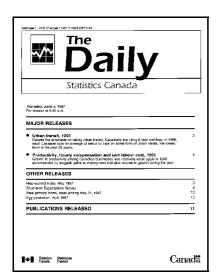
