Farm product prices

August 2007

Prices received by farmers in August for grains, oilseeds, specialty crops, potatoes, cattle, hogs, poultry, eggs and dairy products are now available.

The Ontario wheat price in August was \$206.55 per tonne, up 13% from July and up 71% from August 2006, when the price was \$120.50.

The August slaughter cattle price in Manitoba was \$55.41 per hundredweight, down 9% from July and down 4% from the August 2006 price of \$60.99.

Farm commodity prices are now available on CANSIM. Prices for over 35 commodities are available by province, some series going back 20 years.


