For-hire motor carriers of freight, all carriers

Second quarter 2006

There were an estimated 3,336 for-hire trucking companies based in Canada with annual revenues of \$1 million or more in the second quarter of 2006, almost unchanged from the same quarter in 2005.

Operating revenues totalled \$7.1 billion, up 7.5% from the second quarter of 2005. Operating expenses reached \$6.5 billion, up 8.8% from the same period in 2005.

Both average operating revenues and expenses were up, 7.4% for revenues and 8.7% for expenses, in the second quarter compared with the same quarter of 2005. Average expenses were just under \$2 million compared to \$1.8 million in the same period in 2005. The increase in expenses was driven essentially by higher payments to owners and operators, combined with smaller increases in other expenses and fuel expenses. The operating ratio (operating expenses divided by operating revenues) deteriorated slightly to 0.93 from 0.92 in the second quarter of 2005.

For-hire trucking transportation revenues from domestic movements increased by 9.7% to \$4.6 billion from \$4.2 billion registered one year ago; revenues from international movements increased by 3.2% to \$2.6 billion from \$2.1 billion a year ago.


