## Oil and gas extraction industry: Capital and operating expenditures 2007

Capital expenditures by the conventional oil and gas extraction industry totalled $\$ 31.7$ billion in 2007, down 17.9\% from 2006. The decrease in spending reflected the lower number of exploratory (-39.6\%) and development (-1.7\%) wells drilled in 2007.

Production facilities expenditures were $15.2 \%$ lower than in 2006, the result of decreases in development drilling completions in 2007. Oil and gas rights acquisitions and retention costs also declined in 2007.

With the beginning of new expansion projects, in addition to ongoing developments, the non-conventional sector capital expenditures increased $26.0 \%$ in 2007 to $\$ 18.1$ billion. This marked the third year in a row that expenditures have surpassed $\$ 10$ billion in the non-conventional sector.

According to the Canadian Association of Petroleum Producers, capital expenditures in the conventional and non-conventional sectors are expected to reach $\$ 50$ billion in 2008.

Operating expenses for the conventional sector rose $0.9 \%$ from 2006 to $\$ 26.8$ billion, the result of higher operating costs. For the non-conventional sector, operating expenses reached $\$ 10.9$ billion, an increase of $6.0 \%$ from 2006, due largely to higher royalty payments and operation and maintenance costs.

## Oil and gas extraction industry: Volume and value of marketable production 2007

Crude oil and equivalent production increased to 160.6 million cubic metres in 2007, up $4.2 \%$ from 2006. The marketable production of natural gas and natural gas by-products declined by $2.6 \%$ and $2.3 \%$ respectively in 2007.

The value of crude oil and equivalent hydrocarbons produced in 2007 totalled $\$ 60.9$ billion, up $4.4 \%$ from the $\$ 58.4$ billion in 2006. This growth was attributable to both sustained increases in wellhead prices in 2007 as well as higher production. The value of natural gas marketable production stood at $\$ 39.2$ billion in 2007 ,
down $8.0 \%$ from 2006, largely due to the decline in wellhead prices in 2007. The value of natural gas by-products increased 9.3\% to \$8.7 billion in 2007.

## Domestic sales of refined petroleum products <br> August 2008 (preliminary)

Sales of refined petroleum products totalled 8730.4 thousand cubic metres in August, down 6.3\% compared with the same month a year earlier. Sales were $2.8 \%$ below July 2008. (One cubic metre equals a thousand litres.)

Sales decreased in six of the seven major petroleum product groups in August 2008, with the largest percentage decrease in petrochemical feedstocks (-23.7\%). Heavy fuel oil was the only product to post an increase (+5.3\%).

Motor gasoline sales in August were down 5.4\% compared with the same month a year earlier, the fourth consecutive month with a year-over-year decline.

All grades of motor gasoline posted lower sales. Regular unleaded, which accounted for about $90 \%$ of sales, declined by $3.9 \%$.

Note: Preliminary domestic sales of refined petroleum products data are not available on CANSIM.

## Salary and salary scales of full-time teaching staff at Canadian universities 2006/2007 and 2007/2008 ( supplementary)

Preliminary data on the salaries of full-time teaching staff at 56 Canadian universities for the 2006/2007 academic year and 50 Canadian universities
for the 2007/2008 academic years were released in The Daily on August 2, 2007 and in The Daily on April 9, 2008 respectively.

Information is now available on the salaries of full-time teaching staff at additional Canadian universities, along with information on the salary scales for selected institutions for both the 2006/2007 and

2007/2008 academic years. The institutions that are included are all those that completed the survey by the beginning of October 2008.

The information is collected annually under the University and College Academic Staff System.

As more information becomes available, it will be released periodically. Once information for all institutions has been received, a final report will be issued. Also available are special requests from this data set.
