Automotive equipment rental and leasing 2006

Total operating revenues for the automotive equipment rental and leasing industry declined 1.3% from 2005 to \$5.0 billion, partly because of high gasoline prices.

The industry derived 59% of its operating revenues from the rental of passenger cars. Rental and leasing of trucks, utility trailers and recreational vehicles generated an additional 30%, while passenger car leasing accounted for the remaining 11%.

In terms of operating expenses, vehicle depreciation represented 27% of the total, the largest share, followed by labour costs (17%) and the cost of goods (12%). Operating profit margins remained relatively strong at 8.9%, compared with 9.4% in 2005.

This industry is dominated by large firms. Just over half of the revenues and profits were generated by the 10 largest firms.

Note: Results from the 2006 Annual Survey of Automotive Equipment Rental and Leasing (and revised 2004 and 2005 data) are now available. Previous year figures have been revised to reflect more accurate coverage of the target population, based on information received in the current reference year. These data provide information such as the industry's revenue, expenditures, salaries and wages, and profit margin. Automotive dealerships and the financing arm of automotive manufacturers are excluded from this survey.


