#### **Education matters: Insights on education, learning and training in Canada**

June 2008

This issue of Statistics Canada's free online publication, *Education Matters: Insights on Education, Learning and Training in Canada*, contains two articles.

"Adult learning and the world of work" summarizes findings of a recent report that compared participation in adult learning in Canada with that in three other countries. It found that while participation in organized forms of learning is reasonably high in Canada, it falls short of the levels found in Norway, Switzerland and the United States. The vast majority of adult education and learning in Canada, as well as in the other three countries, is undertaken for job-related reasons.

"Doctoral candidates in Canada in 2004/2005" reports that while almost half of recent doctoral graduates were women, there remained large gender differences across fields of study. Engineering remained the most male-dominated field, while psychology had become the most female-dominated field of study. Slightly less than one-quarter of all graduates were foreign or visa students. Foreign graduates were disproportionately represented in engineering and the physical sciences.

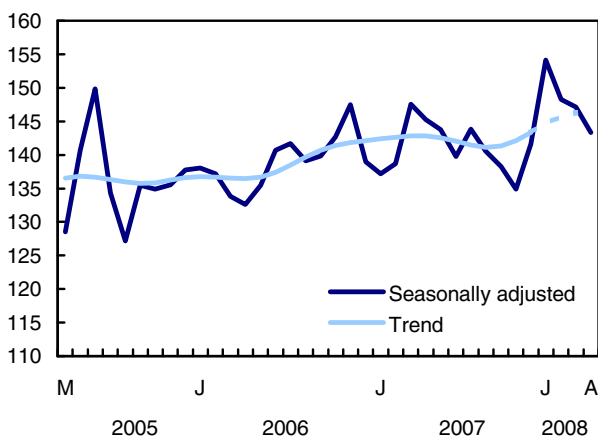
## New motor vehicle sales

April 2008

Sales of new motor vehicles declined for the third consecutive month in April, mainly as a result of lower sales in the western provinces.

**Note:** The last few points could be subject to revisions when more data are added. This is indicated by the dashed line.

According to seasonally adjusted data from the New Motor Vehicle Sales Survey, consumers purchased 143,300 new vehicles in April, down 2.6% from March. Sales have levelled off in recent months after an upswing that began in October 2007.

Looking ahead, preliminary industry data for May suggests that the number of new motor vehicles sold will remain relatively unchanged.

## Overseas-built cars drive April's decrease

Sales of passenger cars fell 5.0% to 75,020 units. Nearly three-quarters of this decline was due to the first

drop in sales of overseas-built passenger cars since November 2007. Even with this decline, overseas-built passenger cars are still following an upward trend. Meanwhile, sales of North American-built passenger cars fell for a third consecutive month, after registering the largest monthly increase in sales in January since 1991.

The number of new trucks (which includes minivans, sport-utility vehicles, light and heavy trucks, vans and buses) sold in April edged up 0.2% to 68,280 units. This was the third consecutive month that truck sales have remained around the same level.

## Sales down in seven provinces

Sales were down in seven provinces in April, with significant declines in Nova Scotia and the four western provinces. The national decline was most influenced by an 8.7% drop in sales in Alberta, where dealers sold the fewest new motor vehicles since December 2005.

Sales increased in New Brunswick, Ontario and Newfoundland and Labrador. The significant gain in New Brunswick brought the number of new motor vehicles sold to its highest level since December 2002.
