## Apartment Building Construction Price Index

Third quarter 2009

The composite price index for apartment building construction decreased 1.6% in the third quarter compared with the previous quarter. As was the case in the second quarter, the decline in the third quarter was mostly the result of increased competitive conditions as a result of a weaker building construction market, most notably in Western Canada.

Among the seven census metropolitan areas (CMAs) surveyed, Vancouver (-3.8%) recorded the largest quarterly decrease while Montréal (+0.7%) had the only increase.

Year over year, the composite price index for apartment building construction was down 9.6%. Of the CMAs surveyed, Vancouver (-18.5%) recorded the largest decrease, while Montréal (+1.5%) and Halifax (+0.1%) had the only increases.

**Note:** In the fourth quarter of 2008, the building model used to calculate the Apartment Building Construction Price Index was replaced with an updated model. Also, the base year was changed to 2002=100.

The apartment building construction price indexes provide an indication of new construction cost changes

in six census metropolitan areas (CMAs) (Halifax, Montréal, Toronto, Calgary, Edmonton and Vancouver) and the Ontario part of the Ottawa–Gatineau CMA.

Besides each of the CMA indexes and the composite index, there are further breakdowns of cost changes by trade groups within the building (structural, architectural, mechanical and electrical). These price indexes are derived from surveys of general and special trade-group contractors who report on the categories of costs (material, labour, equipment, taxes, overhead and profits) relevant to the detailed construction specifications included in the surveys.

## Large urban transit

September 2009 (preliminary)

Combined ridership and revenue levels for 10 of Canada's largest urban transit properties rose in September compared with September 2008.

These 10 companies represent about 80% of total urban transit across the country.

Ridership levels increased 0.6% compared with the same month a year earlier to 135.8 million passenger trips in September.

The rise in ridership pushed revenue (excluding subsidies) up 3.4% from September 2008 to \$242.3 million.

## Canadian potato production

2007, 2008 (revised) and 2009 (preliminary)

Canadian farmers harvested 364,600 acres (147 554 hectares) of potatoes in 2009, resulting in 102,390,000 hundredweight (4 644 410 metric tonnes) being produced. This is down 1% from 2008.

The national yield in 2009 was up 1%. Area planted was down 1% with area harvested down 2%.

**Note:** The publication *Canadian Potato Production* contains tables from the United States' National Agricultural Statistics Service. They contain area planted and harvested, production and value estimates by harvest season.

Canada's balance of international payments, first quarter 2008

The current account surplus with the rest of the world (on a seasonally adjusted basis) increased sharply to \$5.5 billion in the first quarter of 2008, led by higher prices for several exported commodities compared with a lower level of oil. In the financial account, foreign direct investment flows into Canada slowed significantly from the expansion-driven pace of the previous quarter, while Canadian direct investment abroad continued to strengthen.
