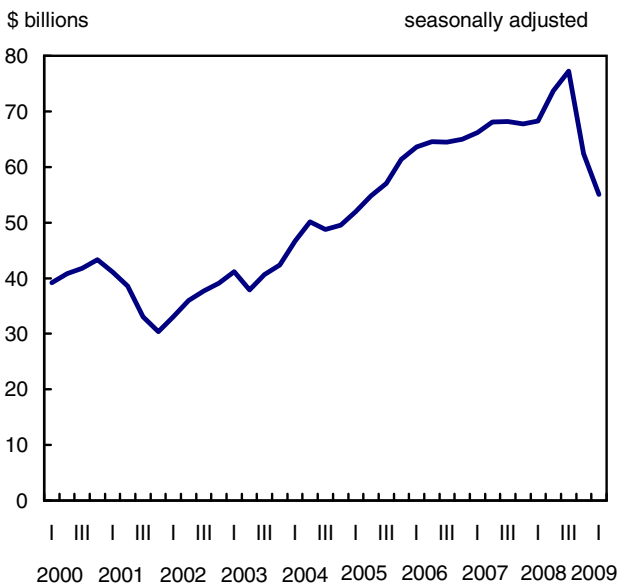
Quarterly financial statistics for enterprises

First quarter 2009 (preliminary)

Lower revenues contributed to declines in profits as Canadian corporations reported operating profits of \$55.1 billion in the first quarter of 2009, down 11.8% from the prior quarter. Declines were prevalent across the economy as 18 of 22 industries reported lower profits.

Profits in the non-financial industries fell 12.6% to \$41.0 billion, while profits in the financial industries contracted 9.3% to \$14.1 billion. Similar to the fourth quarter of 2008, lower profits were mainly attributable to oil and gas extractors and manufacturers.

Operating profits



Oil and gas extractors and refiners post second consecutive decline

Oil and gas extractors and refiners (petroleum and coal products manufacturers) earned lower profits for the second consecutive quarter, as both industries posted declines. Oil and gas extractors earned \$4.3 billion in operating profits, down 33.5% from the fourth quarter

Note to readers

Quarterly financial statistics for enterprises are based upon a sample survey and represent the activities of all corporations in Canada, except those that are government controlled or not-for-profit. An enterprise can be a single corporation or a family of corporations under common ownership and control, for which consolidated financial statements are produced.

Profits referred to in this analysis are operating profits earned from normal business activities. For non-financial industries, operating profits exclude interest and dividend revenue and capital gains/losses whereas for financial industries, these are included along with interest paid on deposits.

Operating profits differ from net profits, which represent the bottom-line profits earned by corporations.

Quarterly profit numbers referred to in the text are seasonally adjusted.

The quarterly financial statistics for enterprises for the period covering 2006 to date have been revised following reconciliation to the 2006 and 2007 annual series. Seasonally adjusted data have been revised back to 1988 to reflect the introduction of the X12 ARIMA process.

of 2008. Petroleum and coal products manufacturers' profits also decreased, down 24.4% to \$1.8 billion.

Manufacturing profits decrease on reduced demand

Manufacturers earned \$8.0 billion in operating profits in the first quarter, down 15.1% from the previous quarter, with the bulk of the decrease coming from the petroleum and coal industry.

Motor vehicle and parts manufacturers reported an operating loss of \$1.8 billion. This was down \$401 million, or 28.2%, from the previous quarter. Plant shutdowns in response to lower consumer demand factored in the declines.

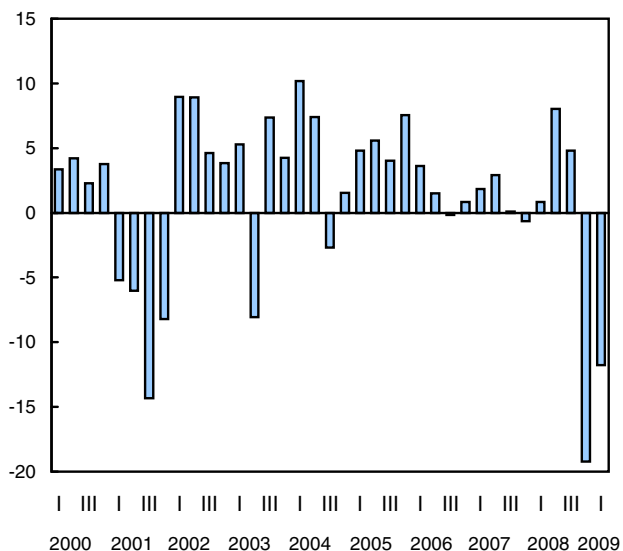
Weaker demand for steel and aluminium also led to lower profits for primary metal manufacturers, as operating profits fell 29.9% to \$666 million.

Wood and paper manufacturers registered an operating loss of \$177 million, as the industry continued to cope with lower demand for lumber and newsprint.

Moderately offsetting losses in the sector were computer and electronic product manufacturers, which posted profits of \$1.3 billion, up 11.1% from the previous quarter, and chemical, plastics and rubber producers, which earned \$2.0 billion in operating profits, up 6.4%.

Mining profits down on potash sales

Lower prices and reduced demand for potash and base metals prompted layoffs in the mining sector, as profits in the industry fell 25.8% to \$1.9 billion.

Profits slow in transportation and warehousing

Transportation and warehousing profits decreased 16.1% to \$2.7 billion, which was consistent

with the lower activity reported in the Monthly Survey of Railway Carloadings for January and February.

Insurance carriers lead declines in financial industries

Insurance carriers led the financial industries to a 9.3% decline in operating profits. Specifically, life, health and medical insurance carriers reported higher claims as well as losses on the sale of securities and other assets, as profits in the quarter fell 56.5% to \$618 million.

Food available for consumption 2008

In 2008, the Canadian diet included more tea, yogurts, breakfast cereals, berries, processed fruits, asparagus, poultry meat and wine, but less oils, red meats and soft drinks. The total daily intake of calories per person fell to 2,382 calories, down 131 calories from the peak recorded in 2001.

Data on food availability have been adjusted to account for losses in cooking, storage and waste that occur in homes, restaurants and institutions while preparing and processing food.

Railway carloadings March 2009

The Canadian railway industry loaded 19.8 million metric tonnes of freight in March, down 13.8% from the same month in 2008.

The drop in tonnage was the result of decreased non-intermodal and intermodal freight loadings.

Compared with the same month last year, non-intermodal loadings fell 14.1% to 17.8 million metric tonnes. The decline occurred as a result of a drop in the majority of the commodities groups carried by the railways. Among the commodities groups with the largest decreases in tonnage were potash, coal,

lumber, iron and steel (primary or semi-finished), and wood pulp.

Despite the overall drop in non-intermodal loadings, wheat, colza seeds (canola) and fresh, chilled or dried vegetables registered strong gains in tonnage loaded compared with March 2008.

Intermodal loadings stemming from containers and trailers loaded onto flat cars fell 11.7% from March 2008 to 2.0 million metric tonnes. Both equipment types (containers and trailers) saw decreased activity.

Rail freight traffic coming from the United States dropped to 2.4 million metric tonnes, down 15.4% from March 2008.

Poultry and eggs

2008

The value of all poultry products increased 13.1% from a year earlier to \$3.2 billion in 2008. Sales of poultry meat, including turkey, increased 15.0% to \$2.4 billion. The value of egg sales increased 7.9% from 2007 to \$823.0 million.

Canadian farmers produced 1.2 million metric tonnes of poultry meat in 2008. Chicken, including stewing hens, accounted for 85% of all poultry meat produced, up 1.2% from 2007. Turkey production stood at 180 000 metric tonnes in 2008, up 6.5% from the previous year.

Egg production reached 579.9 million dozen, up 0.4% from 2007. The central region produced over half of the eggs in Canada with Ontario accounting for 227.8 million dozen eggs and Quebec 100.5 million dozen.

Canada's balance of international payments, first quarter 2009 2
The current account surplus with the rest of the world (on a seasonally adjusted basis) increased sharply to \$5.3 billion in the first quarter of 2009, led by higher prices for several export commodities combined with a lower trade deficit on the financial account. Foreign investment flows into Canada showed significant gains from the acquisition of the price of the previous quarter, while Canada's direct investment abroad continued to shrink.
