The fall 2009 edition of *EnviroStats* contains two articles.

The article "Canada's natural resource wealth, 2008" examines the value of Canada's natural resource assets, including energy, mineral and timber stocks. It presents the value of crude oil, crude bitumen, natural gas, coal, metallic and non-metallic minerals, as well as commercial timber reserves.

The article "Agricultural water use in 2007 – A profile of irrigation" presents information on the number of farms that irrigated in 2007 as well as the area of land irrigated and the volume of water used in different areas of the country. It also shows the sources of water used for irrigation.

Study: Neighbourhood characteristics and distribution of police-reported crime in Toronto

2006

While the city of Toronto as a whole continues to have lower police-reported crime rates than the national average, crime rates in Toronto's neighbourhoods vary. These differences are related to the various socioeconomic, demographic and land-use characteristics of these neighbourhoods.

This study is the eighth in a series of statistical analyses that examine the relationship between higher or lower crime rates and the various neighbourhood characteristics of Canadian cities.

In 2006, rates of police-reported violent crime (which includes crimes such as sexual assault and physical assault) were higher near the downtown core and the east and northwest areas of the city of Toronto.

Neighbourhoods in these areas generally had higher levels of socioeconomic disadvantage and residential mobility, as well as higher population densities.

Rates of property crime (such as shoplifting and theft of motor vehicles) were higher in areas of the city of Toronto with high commercial activity such as shopping centres and certain residential neighbourhoods, most often located near the city centre.

Note: The study "Neighbourhood characteristics and distribution of police-reported crime in Toronto" is part of a series of spatial analyses of crime in Canadian cities conducted by Statistics Canada and funded by the National Crime Prevention Centre at Public Safety Canada. These papers examine crime data at a neighbourhood level using a combination of statistical analyses and crime mapping based on Geographic Information System technology. Other cities analysed include Saskatoon, Thunder Bay, Halifax, Montréal, Edmonton, Regina and Winnipeg.

In this study, socioeconomic disadvantage was measured using the following variables: percentage

of neighbourhood residents with a university degree, percentage of residents without a high school diploma, proportion of total income represented by government transfers, average property value, average personal income, percentage of residents in a lone-parent family, unemployment rate and percentage of residents living in a low income household.
