# **Spending on research and development** 2010 (intentions)

Total research and development (R&D) spending intentions in Canada are anticipated to amount to \$29.2 billion in 2010, down 0.6% from preliminary R&D expenditures for 2009.

The majority of 2010 intended R&D spending, \$14.8 billion (51%), is expected to be spent by companies in the business enterprise sector. This represents a 2.6% decrease from 2009.

Spending on R&D by the higher education sector is anticipated to reach \$11.2 billion in 2010, representing 38% of total spending. This is a 1% increase in R&D spending over 2009.

The federal government follows with anticipated spending of \$2.7 billion in 2010, for a 9% share. This represents a 4.5% increase over 2009.

In terms of R&D funding, the business enterprise sector is expected to provide \$13.7 billion in R&D funds in 2010, down 2.3% from 2009. This represents 47% of total R&D funding.

The federal government, the second largest source of R&D funding, anticipates increasing funding by 2.5% to \$5.8 billion.

**Note:** Data on the national capital regions of Ontario and Quebec are now included with their respective provincial data. This revision has been made back to 1988 in the appropriate CANSIM tables.


# For-hire Motor Carrier Freight Services Price Index

Third quarter 2010

The For-Hire Motor Carrier Freight Services Price Index increased 0.4% in the third quarter from the second quarter.

# For-hire Motor Carrier Freight Services Price Index: Truck transportation

index (2007=100)



The specialized freight trucking component increased 0.2%, while the general freight trucking component increased 0.5%.

On a year-over-year basis, the index advanced 1.3% in the third quarter compared with the third quarter of 2009.

**Note:** With this release, second quarter data are revised and the third quarter are subject to revision. All data in this release are seasonally unadjusted.

The For-hire Motor Carrier Freight Services Price Index is part of the Services Producer Price Index program at Statistics Canada. This is a monthly index which is disseminated on a quarterly basis. The monthly index measures changes over time in prices for the for-hire motor carrier freight services provided by general and specialized freight trucking companies.

The data collected are used to estimate a price index for the truck transportation services sector. The index can be joined with other business service indexes to provide better estimates of real output and productivity, and to monitor inflation in the services sector. Indexes are available at the Canada level only.

#### **Couriers and Messengers Services Price** Index

November 2010

The Couriers and Messengers Services Price Index increased 0.2% in November compared with October. The courier portion rose 0.2% and the local messenger component advanced 0.3%.

On a year-over-year basis, the index advanced 2.7% in November compared with November 2009.

Note: The Couriers and Messengers Services Price Index is a monthly price index measuring the change over time in prices for courier and messenger services provided by long and short distance delivery companies to Canadian-based business clients.

#### **Commercial Software Price Index**

November 2010

The Commercial Software Price Index (CSPI) decreased 0.3% in November from the previous month.

Year over year, the CSPI declined 2.4%.

Note: The Commercial Software Price Index is a monthly series measuring the change in the purchase price of pre-packaged software typically bought by businesses and governments. This release presents data that are not seasonally adjusted and the indexes published are subject to a six month revision period after dissemination of a given month's data.

### Computer and peripherals price indexes

November 2010

From October to November, the price index for commercial computers decreased 1.9% and the index for consumer computers declined 2.1%.

In the case of computer peripherals, monitor prices decreased 1.1% in November compared with the previous month, while printer prices declined 1.0%.

Note: The computer and peripherals price indexes are monthly series measuring changes over time in the price of computers and computer peripherals sold to governments, businesses and consumers. This release presents data that are not seasonally adjusted and the indexes published are subject to a six month revision period after dissemination of a given month's data.

# Industry productivity database 2007

The industry productivity database through the year 2007 is now available. The labour data and capital data that are used by the Canadian Productivity Accounts to estimate labour input, capital input, and multifactor productivity growth in the industry productivity database are also available.

This database provides time series data for multifactor productivity, output and inputs that include capital, labour, energy, materials and purchased services in the North American Industry Classification System (NAICS) back to 1961.

The labour data include hours worked and labour compensation by sex, job category, age group, and educational attainment at a detailed industry level, according to the NAICS for the period 1961 to 2009.

Capital data include investment, capital stock and capital services of different types of physical assets at a detailed industry level, according to the NAICS for the period 1961 to 2007.

These data reflect the latest input-output tables for 2006 (final) and 2007 (final), published in *The Daily* on November 4, 2010; revisions of fixed assets, published in *The Daily* on November 25, 2010, and revisions of hours worked for 2006 to 2009, published in *The Daily* on November 19, 2010.
