

# **Electricity supply and disposition** 2008

Data from the annual Electricity Supply and Disposition Survey are now available for 2008.

The survey provides data on the amount of electricity generated, interprovincial movements of electricity, imports, exports and sales to final consumers.

For the first time, data from this survey are available in two CANSIM tables. Table 127-0007 contains data on electric power generation by class of electricity producer, while table 127-0008 contains data on the supply and disposition of electric power.
