Sawmills

February 2010

Lumber production by sawmills fell 1.8% from January to 4 011.2 thousand cubic metres in February. Compared with the same month in 2009, lumber production increased 14.7%.

Sawmills shipped 3 923.2 thousand cubic metres of lumber in February, down 4.7% from January.

Production and disposition of tobacco products

March 2010

Canadian manufacturers produced 2.1 billion cigarettes in March, up 14.3% from the previous month. The total number of cigarettes sold increased by 50.9% to 2.2 billion and closing inventories declined by 6.4% to 2.0 billion cigarettes in March.

Note: This survey collects data on the production of tobacco products in Canada by Canadian manufacturers and the disposition or sales of this production. It does not collect data on imported tobacco products. Therefore, sales information in this release is not a proxy for domestic consumption of tobacco products.

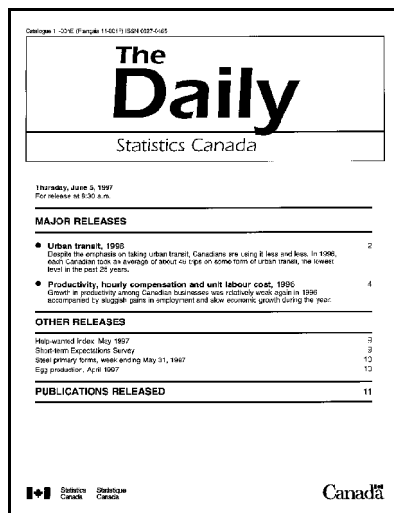
