## Business Conditions Survey: Traveller accommodation industries

Second quarter 2010 (outlook)

The business outlook of Canadian hoteliers for traveller accommodation has improved going into the spring of 2010 compared with expectations a year earlier.

Hoteliers were far less negative about prospects for business in all categories for the second quarter than they were in the same quarter of 2009. However, the proportion anticipating lower business prospects still outweighed those who anticipated improvements.

For example, $24 \%$ of hoteliers expected occupancy rates to increase in the second quarter compared with $4 \%$ a year earlier. On the other hand, $33 \%$ anticipated occupancy rates will decline this spring, well below the proportion of $78 \%$ a year ago.

As a result, the balance of opinion for expected occupancy rates in the second quarter of this year was -9 , compared with -74 for the same quarter in 2009.

Also less negative for the second quarter of 2010 were hoteliers' expectations for average daily room rates, the number of corporate travellers, the number of hours worked by employees, and the number of room nights booked.

Heading into the second quarter, regional economic conditions and excess room supply continued to top the list of business impediments. Exchange rate fluctuations were reported by $30 \%$ of respondents, up from $25 \%$ cited in the last survey.

At the same time, twice as many hoteliers (20\%) reported no impediments, compared with the same quarter one year earlier.

Note: The Business Conditions Survey for the traveller accommodation industries is a voluntary survey sent to 1,414 businesses, mostly hotels. This is the last instalment of this survey as the data series terminates with this release of second quarter 2010 data.

The balance of opinion is determined by subtracting the proportion of traveller accommodation businesses that stated their business activity would be lower relative to the same quarter of the previous year, from the proportion who believed their activity would be higher.

The survey was made possible with the support of industry partners, the Canadian Tourism Commission, the Ontario Ministry of Tourism, Tourism Saskatchewan, Nova Scotia Department of Tourism, Culture and Heritage, and Industry Canada.

## Farm product prices

March 2010
Prices received by farmers in March for grains, oilseeds, specialty crops, potatoes, cattle, hogs, poultry, eggs and dairy products are now available.

The March Quebec soybean price was $\$ 439.00$ per metric tonne, down 5\% from February and down 2\% from March 2009 when the price was $\$ 449.12$.

The Alberta slaughter cattle price in March was $\$ 80.37$ per hundredweight, up $12 \%$ from February but down 7\% from March 2009 when it stood at $\$ 86.29$.

Farm commodity prices are now available on CANSIM. Prices for over 35 commodities are available by province, some series going back 20 years.

## Government Finance Statistics

Fourth quarter 2009
This is the first release of quarterly Government Finance Statistics (GFS), a system which presents fiscal statistics using the international standard GFS developed by the International Monetary Fund. This standard allows consistent aggregation and analysis across countries.

Quarterly GFS data are now available on CANSIM, for overall government in Canada and for four sectors from 1991 to the fourth quarter of 2009.

These sectors are: federal government; provincial/territorial governments; local governments; and Canada and Quebec Pension Plans.

Note: Currently, Government Finance Statistics (GFS) data are being derived by mapping Canada's System of National Accounts data to GFS concepts and conventions. Beginning in 2012, the GFS data will be derived directly from government financial information.

This release presents a report that lists a final set of tables for the academic year 2007/2008, which contain information on the salaries of full-time teaching staff for Canadian universities that have more than 100 staff. Additionally, information on salaries of full-time teaching staff for 2008/2009 is also being released for 14 additional universities.

This information was collected annually under the University and College Academic Staff System and has a reference date of October 1. Therefore, the data reflect employment in universities as of that date. Each university must authorize Statistics Canada to release their information.
