Sawmills

March 2010

Lumber production by sawmills increased 15.4% to 4 627.2 thousand cubic metres in March. Compared with the same month in 2009, lumber production increased 27.8%.

Sawmills shipped 4 383.9 thousand cubic metres of lumber in March, up 11.7% from February.

Production and disposition of tobacco products

April 2010

Canadian manufacturers produced 2.2 billion cigarettes in April, up 6.5% from the previous month. The total number of cigarettes sold decreased by 20.7% to 1.7 billion and closing inventories increased by 22.6% to 2.5 billion cigarettes in April.

Note: This survey collects data on the production of tobacco products in Canada by Canadian manufacturers and the disposition or sales of this production. It does not collect data on imported tobacco products. Therefore, sales information in this release is not a proxy for domestic consumption of tobacco products.

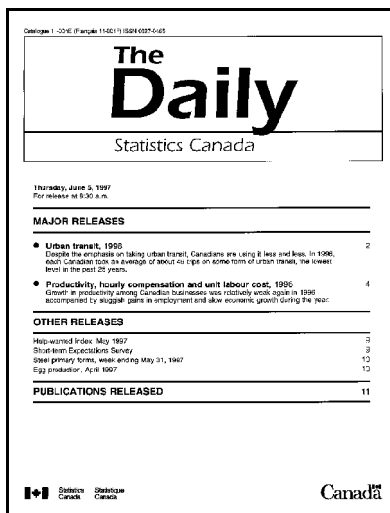
