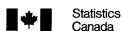

Natural gas sales

April 2010 (preliminary)

Natural gas sales totalled 6 109 million cubic metres in April, up 1.5% compared with April 2009.

The volumes of sales to the residential and commercial sectors were down 6.5% and 5.8% respectively in April compared with April 2009. The volume of sales to the industrial sector was up 7.4% in April compared with April 2009.

Total sales in April were 21.8% lower compared with March.

Canadian Vehicle Survey

October to December 2009

Canadians drove less during the fourth quarter of 2009 compared with the same quarter in 2008. For the fourth quarter, Canadian vehicles were driven 77.4 billion kilometres, down 5.4% from the same quarter in 2008.

The number of vehicles on the road increased by 1.3% in the fourth quarter of 2009.

Canadians drove their vehicles, on average, 3,739 kilometres during the quarter, down 6.6% compared with the same quarter a year earlier.

Note: This will be the final quarterly release from the Canadian Vehicle Survey as this survey has been discontinued. The final annual release, for reference year 2009, is expected to take place in July.

Aircraft movement statistics: Major airports

May 2010

Aircraft take-offs and landings at the 93 Canadian airports with NAV CANADA air traffic control towers and flight service stations decreased 4.0% in May compared with May 2009. These airports reported 539,905 movements in May compared with 562,502 movements in May 2009.


