# Aircraft movement statistics: Small airports

March 2010

The number of take-offs and landings at the 131 airports without air traffic control towers reached 55,054 movements in March. Year-over-year increases were reported by 72 of these airports. Barrie–Orillia–Lake Simcoe Regional, Ontario (2,466 movements) followed by Guelph, Ontario (2,275 movements) were the most active sites in March.
