Production and disposition of tobacco products

May 2010

Canadian manufacturers produced 2.0 billion cigarettes in May, down 5.0% from the previous month. The total number of cigarettes sold decreased by 1.4% to 1.9 billion and closing inventories increased by 3.6% to 2.3 billion cigarettes in May.

Note: This survey collects data on the production of tobacco products in Canada by Canadian manufacturers and the disposition or sales of this production. It does not collect data on imported tobacco products. Therefore, sales information in this release is not a proxy for domestic consumption of tobacco products.

Sawmills

April 2010

Lumber production by sawmills increased 2.9% from March to 4 762.1 thousand cubic metres in April. Compared with the same month in 2009, lumber production increased 29.1%.

Sawmills shipped 4 875.6 thousand cubic metres of lumber in April, up 11.2% from March.
