Canadian Framework for Culture Statistics

The first two issues of the new publication series on the *Canadian Framework for Culture Statistics 2011* are now available. It replaces the 2004 *Canadian Framework for Culture Statistics*.

The first issue of this series, the *Conceptual Framework for Culture Statistics 2011*, presents the conceptual framework, including a definition of culture, domains and sub-domains, and criteria for their inclusion in culture. The second issue, the *Classification Guide for the Canadian Framework for Culture Statistics 2011*, is a guide that maps the conceptual framework to selected standard classification systems. It is intended to foster a standard approach to the measurement of culture in Canada.

Finances of government business enterprises

2010

After-tax profits of federal government business enterprises (GBEs), including monetary authorities, reached nearly \$7.3 billion in 2010, up 67.6% from 2009. This followed declines in 2009.

GBEs are government controlled, public financial and non-financial corporations engaged in commercial operations involving the sale of goods and services to the public in the marketplace.

The total revenues of federal GBEs declined 4.0% in 2010, while total expenses dropped 15.7%, resulting in higher after-tax profits. The largest contributors to this recovery were federal GBEs primarily in the finance, insurance, real estate, rental and leasing and management of companies and enterprises.

Operating subsidies of federal GBEs rose 4.9% in 2010 following a 46.4% increase in 2009; there was no change in share capital.

Total net worth of federal GBEs reached \$27.6 billion in 2010, up 22.2% from a year earlier. Total assets, including fixed assets, declined 2.2%, while total liabilities fell 4.1%.

At the provincial and territorial level, after-tax profits of GBEs reached just over \$18.7 billion in 2010, up 2.7% from 2009. The main contributors to this increase were continued growth in wholesale and retail trade, and recovery in the finance, insurance, real estate, rental and leasing, and personal, business and other services industries.

After-tax profits of provincial and territorial GBEs increased in 10 provinces and territories, with New Brunswick (+133.6%), Saskatchewan (+29.1%) and Alberta (+20.1%) posting the largest percentage gains, while Quebec (-9.6%) and Prince Edward Island (-4.1%) posted the largest declines.

Provincial and territorial GBEs recorded a 1.5% increase in total revenues and a 1.3% increase in

expenses in 2010. Total assets rose 2.9%, while liabilities increased 3.5%. As a result, the total net worth of provincial and territorial GBEs fell 0.2% to \$45.4 billion.

Local GBEs consist of municipally-owned electricity distributors, urban transit companies, gas distributors and telephone companies. Data in this release refer to the fiscal year ending closest to December 31, 2009 for local GBEs as opposed to December 31, 2010 for federal and provincial and territorial GBEs.

In 2009, local GBEs earned after-tax profits of \$776.8 million, down 8.9% from 2008. The main contributors to the after-tax profits continued to be municipally-owned electricity distributors. After-tax profits decreased in all local industries except telephone companies, which reported steady profits of \$31.5 million.

Total revenue for local GBEs reached \$21.4 billion in 2009, down 0.3% from 2008, while total expenses remained virtually unchanged at \$20.5 billion. More than half the revenues for urban transit companies came from subsidies.

te: Financial data for federal, provincial and territorial business enterprises are for the fiscal year ending closest to December 31 and the local government business enterprises for the fiscal year ending closest to December 31 of the previous year. Net income (after-tax profits) is defined as the sum of total revenues minus total expenses plus gains (losses) less corporate income tax plus other items plus extraordinary gains (losses). Data may not add up to totals as a result of rounding.

Natural gas sales

August 2011 (preliminary)

Natural gas sales totalled 4 527 million cubic metres in August, up 5.6% compared with August 2010.

The volume of sales to the industrial sector was up 7.9% compared with August 2010. Meanwhile, the volume of sales to the commercial (-6.5%) and residential (-3.3%) sectors declined.

Total sales in August were 2.4% higher compared with July.

Large urban transit

August 2011 (preliminary)

Total operating revenue (excluding subsidies) for 10 of Canada's largest urban transit properties rose 6.5% from August 2010 to \$226.1 million in August.

These 10 companies represent about 80% of total urban transit across the country.

Ridership levels rose to 114.5 million passenger trips in August, a 5.4% increase from the same month a year earlier.


