## Perspectives on Labour and Income

June 2011 online edition

The June 2011 online edition of *Perspectives on Labour and Income*, released today, features two items.

"Immigrants in self-employment" looks at how self-employed immigrants differ from their non-immigrant counterparts across a number of personal and job characteristics. It also compares the reasons immigrants and non-immigrants report for entering and staying in self-employment.

"The income of immigrants who pursue postsecondary education in Canada" examines a cohort of immigrants who were between 25 and 44 years of age when they arrived in Canada in 1998 and 1999. Changes in their employment income over an eight-year period are studied based on whether these individuals pursued postsecondary education in Canada.

## **Computer and peripherals price indexes** May 2011

Prices for commercial computers increased by 0.8% from April to May, while consumer computer prices declined by 0.7%. In the case of computer peripherals, monitor prices were unchanged in May compared with April, while printer prices declined 1.7%.

Year over year, prices were down for both commercial computers (-13.7%) and consumer computers (-14.0%). Monitor prices decreased by 5.6% while printer prices were down 11.4%.

**Note:** The Computer and peripherals price indexes are monthly series measuring changes over time in the price of computers and computer peripherals sold to governments, businesses and consumers. This release presents data that are not seasonally adjusted and the indexes published are subject to a six month revision period after dissemination of a given month's data.

# **Commercial Software Price Index** May 2011

The Commercial Software Price Index (CSPI) increased by 0.4% from April to May.

Year over year, the CSPI decreased by 5.0%.

**Note:** The Commercial Software Price Index is a monthly series measuring the change in the purchase price of pre-packaged software typically bought by businesses and governments. This release presents

data that are not seasonally adjusted and the indexes published are subject to a six month revision period after dissemination of a given month's data.


