Aircraft take-offs and landings at the 93 Canadian airports with NAV CANADA air traffic control towers and flight service stations decreased 3.4% in June from June 2011. These airports reported 506,342 movements in June.

Production and disposition of tobacco products, June 2012

Canadian manufacturers produced 1.9 billion cigarettes in June, down 3.8% from the previous month. The total number of cigarettes sold decreased 2.5% to 1.9 billion and closing inventories decreased 2.1% to 2.6 billion cigarettes.
