Commercial Software Price Index, September 2013

The Commercial Software Price Index (CSPI) decreased by 1.5% in September compared with the previous month.

Year over year, the CSPI was up by 0.7%.

Note to readers

The Commercial Software Price Index is a monthly series measuring the change in the purchase price of pre-packaged software typically bought by businesses and governments. This release presents data that are not seasonally adjusted, and the indexes published are subject to a six-month revision period after dissemination of a given month's data.

Computer and peripherals price indexes, September 2013

Prices for commercial computers increased 1.8% from August to September, while consumer computer prices decreased 0.6%. In the case of computer peripherals, monitor prices were down 0.7% while printer prices were up 0.4%.

Year over year, prices increased for commercial computers (+2.4%) but were down for consumer computers (-3.9%). Monitor prices declined 1.6% while printer prices rose 4.5%.

Note to readers

The computer and peripherals price indexes are monthly series measuring changes over time in the price of computers and computer peripherals sold to governments, businesses and consumers. This release presents data that are not seasonally adjusted, and the indexes published are subject to a six-month revision period after dissemination of a given month's data.

Production and disposition of tobacco products, September 2013

Canadian manufacturers produced 1.8 billion cigarettes in September, up 7.2% from the previous month. The total number of cigarettes sold decreased by 2.9% to 1.9 billion.

Crop Condition Assessment Program, September 2 to October 7, 2013

The Normalized Difference Vegetation Index (NDVI) database is now available on CANSIM for the period from September 2 to October 7. The database holds the mean value of the one-kilometre resolution satellite picture elements within each of the census agriculture regions or census consolidated subdivisions of Canada with pasture and/or cropping activity. The Crop Condition Assessment Program database is updated weekly from mid-April to mid-October.

NDVI data have been disseminated through the Crop Condition Assessment Program web application since 2000. The addition of NDVI data to CANSIM makes the data readily available to everyone.

Note to readers

Agriculture and Agri-Food Canada, through the Growing Forward program, has partnered with Statistics Canada to provide the Crop Condition Assessment Program application free of charge. The Canada Centre for Remote Sensing, part of Natural Resources Canada, has also contributed by providing software for processing the input satellite data.
